Minutes of a Regular Meeting of the Verona Township Council on Monday, December 17, 2018 beginning at 7:00 p.m. in the Municipal Building, 600 Bloomfield Avenue, Verona, New Jersey.

Call to Order:

Municipal Clerk reads notice of Open Public Meetings law. The notice requirements of the Open Public Meetings Act have been satisfied with respect to this meeting; specifically, the time, date and location were included in the annual notice of meetings adopted by the governing body, posted in the Municipal Building, and sent to the official newspapers of the Township, the Verona Cedar Grove Times and the Star Ledger. Additionally, the agenda for this meeting was posted in the Municipal Building and sent to the two newspapers before 4:30 p.m. on the Friday preceding this meeting.

Roll Call:

Mayor Kevin Ryan, Deputy Mayor Nochimson, Councilman Alex Roman, Councilman Ted Giblin and Councilman Jack McEvoy are present. Township Attorney Brian Aloia, Township Manager Matthew Cavallo and Municipal Clerk Jennifer Kiernan are also present.

Mayor Ryan leads the Pledge of Allegiance.

Mayor's Report:

Mayor Ryan calls Essex County Liaison Jay Coltre to the lectern. Mr. Coltre announces the 2018 Essex County Holiday Lights Spectacular at the Turtle Back Zoo run through the end of the year. He also states the swearing in of the County Executive will take place at noon on January 2 at the Donald M. Payne Sr. School of Technology in Newark. He wishes everyone a safe, happy and healthy holiday season.

Mayor Ryan attended a meeting hosted by the County Executive for all mayors and township administrators on December 15 along with Township Manager Matthew Cavallo. Assemblyman Stephen Sweeny presented the fiscal condition of the State. The Mayor states a resolution endorsing the findings and recommendations of the State committee will be on the January 7 Township Council Meeting agenda.

Manager's Report:

Matthew Cavallo states that the topic of public participation with respect to Council Meetings will be on the January 7 meeting agenda.

Bids were received for the Fairway Avenue Water Tank Rehabilitation, the DPW Garage Fire Sprinkler System and the Loading, Transportation and Delivery of Liquid Sludge. Bids are still being reviewed and will be awarded in January.

The 2019 Town Calendar is currently being finalized and is expected to be mailed out in early January. The 2018 Calendar included January 2019.

The Leaf Dump is now closed for the season. Yard debris is to be disposed of via curbside collection.

Christmas Tree Collection begins in January. Discarded Christmas trees are to be placed at the curb for removal by the Garbage Hauler and the DPW. Remove all lights and ornaments from the tree. No trees should be placed at the curb in plastic bags. Discarded trees cannot be brought to the Leaf Dump this year; they must be put out at the curb.

There will be no curbside garbage collection on Tuesday, December 25 (Christmas Day) or on Tuesday, January 1 (New Year's Day). There is no scheduled make-up day so the next garbage collection will be Friday, December 28 and Friday, January 4 respectively. The makeup recycling collection day is Wednesday, December 26 (Southside Commingled) and Wednesday, January 2 (Southside Cardboard and Paper). Please see the calendar for more details.

The Township has completed our cleaning of the 20" Sewer Trunk Line that runs from north of

Bloomfield Avenue to the Sewer Plant. The Township is currently working with our Sewer Engineer to develop specifications to conduct a similar cutting and cleaning operation of the other two main trunk lines in Town. Several sections near the plant need to be repaired or replaced and are scheduling this work to be done in-house.

The Memorandum of Agreement between the Township and PBA Local 72 has been ratified by a majority of the PBA Members and is being presented tonight to the Township Council for approval. The Township Manager thanks the members of the PBA and Council in successfully negotiating a contract.

Steven Neale is being reappointed as the Class II Member of the Planning Board for a term beginning on January 1 and ending on December 31, 2019.

Joel Martin is the being appointed as the Coordinator of the Office of Emergency Management for a term beginning on January 1, 2019 and ending on December 31, 2021.

There are several School Crossing Guards positions available. The Township Manager urges the public to apply if they are the time.

Councilmember's Reports:

Deputy Mayor Nochimson reports he has been informed by the Township Manager that open gym will take place on Sundays in the Community Center between January 6 and March 3 from 4:30pm – 6:30pm. From March 10 through March 31, the gym will be open to the public from 2pm - 5pm.

Councilman Roman reports that he reviewed the Planning Board's Environmental Resources Inventory, a comprehensive document of the inventory of the environmental assets of the Township, which he stated, is a well-done document.

Councilman McEvoy reports he attended the grand opening of Olive That and will attend the GuacSpot's grand opening tomorrow. He urges the public to continue to support local restaurants. He requests an update on the revaluation. The Township Manager states the Tax Assessor's office has reported that the first letters will go out the week after Christmas.

Councilman Giblin comments that Congressman Rodney Frelinghuysen's term is ending. He thanks the Congressman for his service and wishes him well in retirement.

WHEREAS, pursuant to *N.J.S.A.* 52:34-6.2b.(3) (as amended by *P.L.* 2011, *c*.139) and LFN 2012-10, a New Jersey municipality may purchase goods and services without public bidding under the Local Public Contracts Law through the use of a nationally-recognized and accepted cooperative purchasing contract that has been developed utilizing a competitive bidding or contracting process by another contracting unit within New Jersey or another state; and

WHEREAS, Sourcewell is a regional organization of governments operating under the laws of the State of Minnesota and is a political subdivision of the State of Minnesota; and

WHEREAS, the subject cooperative purchasing contract was awarded by Sourcewell to John Deer utilizing a competitive contracting process; and

WHEREAS, also pursuant to *N.J.S.A.* 52:34-6.2b.(3) (as amended by *P.L.* 2011, *c*.139) and LFN 2012-10, prior to making purchases under nationally-recognized and accepted cooperative purchasing contracts, the municipality must determine that the use of the cooperative purchasing contract shall result in cost savings after all factors, including charges for service, material, and delivery, have been considered; and

WHEREAS, the Department has determined that Verona's use of the Sourcewell cooperative purchasing contract to procure the sought-after front end loader will result in cost savings to Verona; and

WHEREAS, consistent with the Sourcewell cooperative purchasing contract and needs of Verona, John Deer has submitted a proposal to provide one John Deere 544L Front End Loader to Verona for the sum of \$155,381.72; and

WHEREAS, the Chief Financial Officer has certified that sufficient funds are available for this purchase.

WHEREAS, the award of the contract to R&R Pump and Control Services, LLC is being made pursuant to *N.J.S.A.* 19:44A-20.5; and

WHEREAS, the cost for said professional services shall exceed \$17,500.00 as outlined in the proposal without further authorization by the Township Council; and
