Minutes of a Regular Meeting of the Verona Township Council on Monday, April 8, 2019 beginning at 7:00 p.m. in the Municipal Building, 600 Bloomfield Avenue, Verona, New Jersey.

## Call to Order:

Municipal Clerk reads notice of Open Public Meetings law. The notice requirements of the Open Public Meetings Act have been satisfied with respect to this meeting; specifically, the time, date and location were included in the annual notice of meetings adopted by the governing body, posted in the Municipal Building, and sent to the official newspapers of the Township, the Verona Cedar Grove Times and the Star Ledger. Additionally, the agenda for this meeting was posted in the Municipal Building and sent to the two newspapers before 4:30 p.m. on the Friday preceding this meeting.

## Roll Call:

Mayor Kevin Ryan, Deputy Mayor Nochimson, Councilman Ted Giblin and Councilman Jack McEvoy are present. Township Attorney Brian Aloia, Township Manager Matthew Cavallo and Municipal Clerk Jennifer Kiernan are also present. Councilman Roman is absent.

Mayor Ryan leads the Pledge of Allegiance.

## Mayor's Report:

Mayor Ryan reads a proclamation for Child Abuse Prevention Month and presents it to Junior Woman's Club members Robyn Casella and Catherine Crevoiserat.

Mayor Ryan reports that he attended a meeting of the mayors of Essex County in Newark with the Governor and County Executive. The Governor rolled out the 2020 budget highlights. He also attended a breakfast hosted by the West Essex Chamber of Commerce where Senator Sweeney and Assemblyman Bramnick gave an update on the State Budget.

Mayor Ryan announces that the Council will go into closed session tonight to discuss Affordable Housing.

#### Manager's Report:

The Township Manager reports that there will be a case management conference on April 26, 2019 regarding Affordable Housing and a case management conference on June 7 where he expects the judge to set the trial or fairness hearing date.

This Saturday the Environmental Commission will have a clean-up in the Grove Avenue pocket park. The Verona Park Conservancy will have a clean-up on Saturday as well.

The PSEG Direct Energy Program determined the air conditioning unit in Town Hall needs to be replaced and it currently dismantled until a part is available.

With the completion of one quarter with the new Pitman Schedule for the Police Officers and Dispatchers the Township saw a 81% reduction in OT hours and a 76% reduction in pay for the Officers and an 81% reduction in OT hours and a 79% reduction in OT pay for the Dispatchers.

The Township will enter into a shared services agreement with Caldwell whereby the DPW will water their flower baskets along Bloomfield Avenue along with the monthly street sweeping, which has already begun.

The Municipal Roof replacement has begun. The new roofing material has been installed. Restoration of the cupola is underway. The construction of the entrance awning by the Police Department to begin in the next few weeks.

The Township Manager gives an update on the Verona Water Quality Report and addresses concerns. He reports that Verona's water is safe and has posted water quality reports back from 2009 in the Township website.

Glenn Houthuysen, Chairperson of the Historical Preservation Commission gives a

presentation on behalf of the Commission and encourages homeowners to designate their homes as historic if they are identified as landmarks in the Commission's report.

The Township Manager appoints Lenny Waterman to the SWAC to fulfill the unexpired term of Gerard Shimonaski.

# **Councilmember Reports:**

Deputy Mayor Nochimson reports several residents have expressed concerns about closing the leaf dump. He suggests the Township should have a dumpster at the Recycling Center during the autumn months for residents to dispose of heavy brush.

Councilman McEvoy reports the Chamber of Commerce will hold a workshop from 8:00 am – 9:30 am at the VCC. He wishes the VBSL Verona youth a good season.

Councilman Giblin reports the VBSL parade was a success. He reminds residents that pool registration is open. He also requests an update on the Route 23 construction. The Township Manager states the project is scheduled for completion in January 2020.
