Minutes of a Regular Meeting of the Verona Township Council on Monday, May 6, 2019 beginning at 7:00 p.m. in the Municipal Building, 600 Bloomfield Avenue, Verona, New Jersey.

Call to Order:

Municipal Clerk reads notice of Open Public Meetings law. The notice requirements of the Open Public Meetings Act have been satisfied with respect to this meeting; specifically, the time, date and location were included in the annual notice of meetings adopted by the governing body, posted in the Municipal Building, and sent to the official newspapers of the Township, the Verona Cedar Grove Times and the Star Ledger. Additionally, the agenda for this meeting was posted in the Municipal Building and sent to the two newspapers before 4:30 p.m. on the Friday preceding this meeting.

Roll Call:

Mayor Kevin Ryan, Deputy Mayor Nochimson, Councilman Roman, Councilman Ted Giblin and Councilman Jack McEvoy are present. Township Attorney Brian Aloia, Township Manager Matthew Cavallo and Municipal Clerk Jennifer Kiernan are also present.

Mayor Ryan leads the Pledge of Allegiance.

Mayor's Report:

Mayor Ryan reads a proclamation for National Small Business Week and presents it to Catherine Samarati and Township of Verona Director of Economic Development Steven Neale.

Mr. Ryan invites Jay Coltre, Essex County Liaison to the lectern. Mr. Coltre reports that last weekend the County held their annual recycling of hazardous waste. The County Environmental Center will hold a Mother's Day plant sale on May 11. There will be an open house at the Turtle Back Zoo from 10am – 2pm with free entry.

Mayor Ryan reports that he attended the candidate's forum on May 1 and extends his compliments to the 5 candidates. He states that the candidates has limited time to respond and issues were left dangling therefore, he feels the need to clarify some issues. In regards to Affordable Housing, the Township is still negotiating with an intervener and there is a current agreement with Poekel.

Manager's Report:

The Township Manager reports that in observation of the Ramadan Holiday, which runs from Sunday, May 5 through Tuesday, June 4, the Township's overnight parking restrictions are being relaxed until June 4.

The official letter for the Sustainable Essex Alliance Energy Aggregation Program was mailed from the Energy Consultant Gabel Associates last week notifying residents of the SEA CCA program and their new electric supply. An article has been posted on the homepage of the Township's website and shared on all of our social media platforms. An email was also sent out through Community Pass. All residents are encouraged to read the materials carefully. There will be an information session on Wednesday, May 15 at 7:00 p.m. in the Annex Building at the Community Center.

The Municipal Building Roof Replacement project is still underway. The new roofing material has been installed. Restoration of the cupola is underway. We expect the construction of the entrance awning by the Police Department to begin in the next two weeks.

Roadway Reconstruction and Resurfacing Projects include Brentwood Road reconstruction (from Cumberland Avenue to Otsego Road). Stanziale has completed the concrete work that was required prior to paving. We are waiting a few nice days, hopefully in the next two weeks to mill and pave the entire street. Harrison Street, Park Avenue and South Prospect Street reconstruction. (Park Avenue from Sunset Avenue to Hathaway Lane & South Prospect Street from Bloomfield Avenue to Pease Avenue): this project is scheduled to be awarded tonight by the Township Council. A majority of the funding for this project has come from a grant from the New Jersey Department of Transportation. This project should begin around the end of May and be

completed by the end of August. Linn Drive reconstruction: this project is currently out to bid and is scheduled to be awarded by the Township Council on May 20. A majority of the funding for this project has come from two grants from the Federal Community Development Block Grant Program administered by the County of Essex.

The Township's annual resurfacing project is scheduled to begin in the middle of June. A list of streets to be resurfaced include: Birdseye Glen – entire length, Brookside Terrace – from Franklin Street to Peckman Court, Cumberland Avenue – from Bloomfield Avenue to Edgemere Road, Elmwood Road – from Bloomfield Avenue to Claremont Avenue, Fellswood Road – entire length, Glen Road – entire length, Lakeview Place – entire length, Malvern Place – entire length, Morningside Road – entire length, Nassau Road – entire length, Ravine Road – entire length, Robert Court – entire length, Rose Terrace – entire length, South Prospect Street – from Pease to Morningside Road, Stonewood Parkway – entire length, Valley View Road – entire length, Westover Road – entire length, Witherspoon Road – entire length and Woodland Avenue – from Otsego Road for 500 feet.

The Municipal Elections are being held on Tuesday, May 14. The Township Manager wishes all the candidates running for office good luck. The polls will be open from 6:00 a.m. to 8:00 p.m. The Clerk's Office will be open at that time if any residents have any questions or concerns. The last day to register to receive an absentee ballot is tomorrow.

AUTHORIZING THE PLANNING BOARD TO UNDERTAKE A NEW

PRELIMINARY INVESTIGATION TO RECONSIDER WHETHER BLOCK 303, LOT 4 QUALIFIES FOR AS AREA IN NEED OF REDEVELOPMENT

WHEREAS, the Local Redevelopment and Housing Law, *N.J.S.A.* 40A12A-1 *et seq.* (the "Redevelopment Law"), provides a mechanism to empower and assist local governments in efforts to promote programs of redevelopment; and

WHEREAS, the Township Council of the Township of Verona ("Township") desired to explore whether that certain real property located at the intersection of Bloomfield Avenue and Sunset Avenue, more commonly known as Block 303, Lot 4 on the Township Tax Map, inclusive of any and all streets, "paper" streets, private drives and right of ways (collectively, the "Study Area") may be an appropriate area for consideration for the program of redevelopment; and

WHEREAS, the Redevelopment Law sets forth a specific procedure and criteria for establishing an area in need of redevelopment; and

WHEREAS, on or about January 7, 2019, by Resolution 2019-29, the Township Council authorized and directed the Township Planning Board to conduct the necessary investigation and to hold a public hearing to determine whether the Study Area qualified for designation as a Non-Condemnation Redevelopment Area under the Redevelopment Law; and

WHEREAS, Jason L. Kasler, AICP, PP of Kasler Associates, PA prepared that certain study titled "2019 Township of Verona New Jersey, Property located at 1 Sunset Avenue, Verona, NJ 07044, Block 303 Lot 4, Determination of Area in Need of Redevelopment" dated January 20, 2019 (the "Kasler Study"); and

WHEREAS, on or about January 31, 2019, the Planning Board conducted a public hearing to consider the Kasler Study and to investigate whether or not the Study Area qualified for designation as a Non-Condemnation Redevelopment Area under the criteria and pursuant to *N.J.S.A.* 40A:12A-1 *et seq.*; and

WHEREAS, on or about February 6, 2019, the Planning Board Secretary submitted its findings to the Township Council (the "Planning Board Memo"), stating that the Planning Board determined that the Study Area did not meet the criteria to qualify as an area in need of redevelopment and declined to recommend that the Study Area be designated a Non-Condemnation Redevelopment Area; and

WHEREAS, the Township Council has considered the Planning Board Memo and desires to commission a new study of the Study Area and to refer said new study to the Planning Board for reconsideration of the Study Area as an area in need of redevelopment,

NOW, THEREFORE, BE IT RESOLVED that the Township Council hereby authorizes and directs the Township of Verona Planning Board to conduct a new investigation and to hold a public hearing to determine whether the Study Area defined hereinabove qualifies for designation as a Non-Condemnation Redevelopment Area under the criteria and pursuant to the public hearing process as set forth in *N.J.S.A.* 40A:12A-1 *et seq.*; and

BE IT FURTHER RESOLVED that the Planning Board shall submit its findings and recommendations to the Township Council in the form of a Resolution or Memorandum with supportive documentation.

BE IT FURTHER RESOLVED that a certified copy of this Resolution be forwarded to the Township Planning Board and the Planning Board Secretary.
