Minutes of a Regular Meeting of the Verona Township Council on Monday, June 3, 2019 beginning at 7:00 p.m. in the Municipal Building, 600 Bloomfield Avenue, Verona, New Jersey.

Call to Order:

Municipal Clerk reads notice of Open Public Meetings law. The notice requirements of the Open Public Meetings Act have been satisfied with respect to this meeting; specifically, the time, date and location were included in the annual notice of meetings adopted by the governing body, posted in the Municipal Building, and sent to the official newspapers of the Township, the Verona Cedar Grove Times and the Star Ledger. Additionally, the agenda for this meeting was posted in the Municipal Building and sent to the two newspapers before 4:30 p.m. on the Friday preceding this meeting.

Roll Call:

Mayor Kevin Ryan, Councilman Roman, Councilman Ted Giblin and Councilman Jack McEvoy are present. Township Attorney Brian Aloia, Township Manager Matthew Cavallo and Municipal Clerk Jennifer Kiernan are also present. Deputy Mayor Nochimson is absent.

Mayor's Report:

Mr. Ryan invites Jay Coltre, Essex County Liaison to the lectern. Mr. Coltre reports the County Summer Music Series will hold a concert on June 26 in Verona Park at 7:30 pm. Fireworks will be at Brookdale Park on June 28 and July 1 at Weequahic Park. Councilman Giblin requests Mr. Coltre report to the County that the flagpole at the south-side of the lake in Verona Park needs a flag. Mayor Ryan states there is a leakage problem under the benches on the Lakeside Avenue section of the park. Mr. Coltre will report back.

Mayor Ryan reads a proclamation for National Gun Violence Awareness week. Members from Mom's Demand Action are present. Katy McClure, a Fellow with the Gun Survivor Network approaches the lectern and presents an emotional and personal account of how gun violence affected her family.

Manager's Report:

Mr. Cavallo expresses his gratitude to the County for working with the Township for tonight's ordinance on for introduction that authorizes the acquisition of the "teardrop" property located at the corner of Linn Drive and Bloomfield Avenue from the County of Essex for one dollar plus use of the Community Center for public hearings at no charge. The Township currently has a 50-year lease on the property. This parcel is included in the Depot and Pine Redevelopment Area.

Ordinance G-2 is a Bond Ordinance authorizing \$1,260,000 from the General Capital Fund to fund the replacement of a Fire Engine (Engine 10 – Station 1) and an Ambulance (Rescue 9). Engine 10 is a 1999 Pierce Dash Pumper. Rescue 9 is a 2008 Ford Ambulance. I intend to purchase both vehicles under the HGAC Cooperative Contract. Under these contracts, Engine 10 is expected to cost approximately \$715,000 with equipment and Rescue 9 is expected to cost approximately \$345,000 with equipment.

Ordinance G-3 is an Ordinance codifying three on-street handicapped parking spots throughout the Township. Requested by the Police Department.

Ordinance 2019-16 adopts a Redevelopment Plan for the Depot and Pine Redevelopment Area. This Ordinance was referred to the Planning Board and it was found to be consistent with the Master Plan at their regular meeting on Thursday, May 23. A public hearing and adoption of the Redevelopment Plan is planned for the next regular meeting of the Township Council on Monday, June 17.

Resolution 2019-99 – Refers the Spectrum 360 property back to the Planning Board for a second review to determine if the property meets the requirements of a non- condemnation area in need of redevelopment. The Planning Board voted to hire Mr. Fred Suljuc, PP to conduct a new Area in Need of Redevelopment Survey of the property and we expect this survey to be completed

in the next two weeks.

Police Overtime from January - May 2019 saw a 70% reduction in OT hours / 64% reduction in OT pay. Dispatch Overtime from January - May saw an 87% reduction in OT hours / 85% reduction in OT pay.

The Do Not Knock Registry is now in effect. A currently list is posted to the Township Clerk's webpage.

Construction of the entrance awning by the Police Department started last week with the excavation of the footings required.

Stanziale has substantially completed the reconstruction of Brentwood Road. I expect this project to be closed out within the next few weeks. The Township's annual resurfacing project is scheduled to begin this Wednesday and be completed in ten days (weather permitting).

There are openings on several Boards and Commissions. In addition, there are some positions that are vacant on July 1 due to expiration of terms. Any resident who wishes to be considered for any position on a Board or Commission is requested to submit an application on the Township's website. Anyone with questions, please contact the Township Clerk's Office.

Primary Election Day – Tuesday, June 4. Polls open from 6:00 a.m. to 8:00 p.m.; Verona Pool opens full time on Friday, June 21; Fireworks at the Verona Community Center – Monday, July 1 (rain date Tuesday, July 2). The fireworks will be held at the Verona Community Center starting at dusk. Music and entertainment will begin at 7pm on Liberty Field off White Rock Road. Verona Summer Concert Series – July 10, 17, 24 and 31. Movie Under The Stars – Tuesday, August 20 (rain date Wednesday, August 21).

Steve Neale approaches the lectern and gives an overview presentation of the Township's website.

Councilmember Reports:

Councilman Roman reports that he visited the facilities and employees of the Township. He comments on how busy the Township is during the day, which he found quite impressive. He thanks the Township Manager, Department Heads and employees for the excellent service they provide the Township.

Councilman McEvoy expresses his condolences for the residents of Virginia Beach. He hopes our State legislature will sit down and try to change gun laws, although it is a nationwide problem. The Councilman thanks all who came out for the Memorial Day parade and all who gave their life so we can enjoy freedom here in the United States. He congratulates the Artist Frame Galley, who recently celebrated their 50th anniversary in the Township.

Councilman Giblin acknowledges the Mom's Demand Action group and states he found Ms. McClure's testimony compelling. He reports that the he attended the VBSL pool party. He expresses his gratefulness to be able to have the opportunity to be a part of a great organization. He reports that he met last week with Superintendent Dionisio to discuss PILOT money.
