#### Call to Order:

Municipal Clerk reads notice of Open Public Meetings law. The notice requirements of the Open Public Meetings Act have been satisfied with respect to this meeting; specifically, the time, date and location were included in the annual notice of meetings adopted by the governing body, posted in the Municipal Building, and sent to the official newspapers of the Township, the Verona Cedar Grove Times and the Star Ledger. Mr. McEvoy invites Jay Coltre, Essex County Liaison to the lectern. Mr. Coltre reports the County Summer Music Series continue throughout the summer. Councilman Giblin requests Mr. Coltre inform the public of the renovations to the Hall of Records building in Newark.

Mayor McEvoy reads a proclamation for National Night Out, taking place on August 6.

Mr. Cavallo explains that Resolution 2019-99 on tonight's agenda refers the Spectrum 360 property back to the Planning Board for a second review to determine if the property meets the requirements of a non- condemnation area in need of redevelopment. The Planning Board voted to hire Mr. Fred Suljuc, PP to conduct a new Area in Need of Redevelopment Survey of the property. A draft of report has been published and a new review by the Planning Board is scheduled for July 25 at 7:30 p.m. at the Community Center Ballroom.

He explains that Police Overtime – January – June saw a 64% reduction in OT hours / 58% reduction in OT pay (minus \$64,260) and Police Comp Time (TC) – January – June 2019 saw a 50% reduction in TC hours earned (minus \$32,127 cash value).

The Municipal Building Roof Replacement Construction of the entrance awning by the Police Department has resumed following an error in steel installation.

The Township's annual resurfacing project was completed and the line striping was finalized this past week. 6,820 tons of asphalt was used in this project. The cost was \$625,000.

The Reconstruction of Park Avenue, South Prospect Street and Harrison Street has been awarded and is scheduled to begin in the upcoming weeks.

Fairway Tank Rehabilitation project is underway and is scheduled to be completed in the fall.

Library Generator project is underway. The generator pad has been poured and the Township is waiting for the delivery of the generator.

DPW Garage Fire Sprinkler System, funded by the 2015 governing body, is substantially complete and the Township is waiting for the closeout documents.

The material for the Mechanical Bar Screen project has been ordered and will be installed once it arrives. This project should be completed in the fall.

This project of Lowering of Tricking Filters has been awarded and the contracts have been signed. A preconstruction meeting is scheduled for the week of July 22.

The solicitation for the bid of Lease Extensions on the Linn Drive Tower is out at this time. The Bids are due back on August 13. The new Lease Contracts are estimated to begin on September 1.

The solicitation for the HVAC Service Contract & New Work bid is out at this time for a two year contract.

The Junior Woman's Club of Verona has created Packs with Purpose to help families within our community who will struggle to purchase the items their children will need to begin school this fall. Anyone interested can purchase items and drop them in collections bins at the Verona Community Center, Platinum Fitness, Walgreens and the Library. The Juniors are also having a Pack with Purchase drive at Walgreens and Staples on Friday August 2nd or Sunday August 4<sup>th</sup>. More information and information on sponsoring a student is located on the Juniors' website.

The Township has recently added events to the Township of Verona – Government Facebook Page for the Council Meetings, Planning Board Meetings, and Board of Adjustment Meetings for the remainder of the year. If you would like to add them to your Facebook Events Calendar, just click on the "interested" button for the events you would like to follow.

The Township has added Contract Us Links for every board/committee/commission that Verona has on the individual committee's webpages. The links bring you visitors to a Contact Us form to send an email to the representatives of the committees.

The 2019 Water Quality Report has been published and has been mailed to every home in our service area. Additionally the report has been published to the Township's website. On our website, visitors can also find past Water Quality Reports dating back to 2009.

As has been standard practice in the past, Estimated Tax Bills were mailed out to all Verona Taxpayers at the end of June. Bills are estimated because the State of New Jersey did not pass their budget until June 30 and as such was unable to certify State Aid to municipalities, counties and school boards before July 1. Since State Aid was not certified, the County Board of Taxation was unable to certify the Tax Rate.

Since Verona underwent a Revaluation this past year, it is important to note that the 3<sup>rd</sup> (and 4<sup>th</sup>) Quarter Tax Payments on your Tax Bill do not reflect what your new "standard" tax payment will be. The 3<sup>rd</sup> & 4<sup>th</sup> Quarter bills reflect the total change in annual property taxes for 2019 (remembering that taxpayers already paid their 1<sup>st</sup> and 2<sup>nd</sup> Quarter Payments at last year's tax rate). Therefore, you should not multiply your 3rd or 4th Quarter bill by 4, as you will overestimate your annual property taxes.

Recycling has become confusing recently due to market changes. We do still encourage residents

to recycle but we must stress how important it is to do it correctly. We need to make sure the stream is as clean as possible so all the materials get collected. If you are unsure if something is recyclable, it is best to throw it out instead of throwing it in with all the other recycling.

Materials that don't belong can contaminate entire loads and that is what we are trying to avoid. "When in Doubt, Throw it Out." New infographics have been posted at the Recycling Center and on the Township Website that we hope will be helpful and together we can clean up our recycling stream.

Lastly, please note that leaf bags are for leaves and vegetative waste only. Please do not throw regular garbage in with the vegetative waste. It is costing us money.

The Summer Concert Series continues on Wednesdays, July 17, 24 and 31. Movie Under The Stars – "A Dogs Way Home" is Tuesday, August 20 (rain date Wednesday, August 21) And Verona Restaurant Week 2019 is September 15-19.

### Councilmember Reports:

Deputy Mayor Roman reports that this year's Summer Concert Series has a great line-up of performers. He stresses a policy priority is that the Township needs to work on a wireless communications ordinance for smaller cell sites.

Councilman Ryan reads an email he received form Father Joe D'Amico of OLL congratulating him on his past service as Mayor. He questions the Township Manager on the construction on Derwent. Mr. Cavallo states that PSE&G is going to replace the gas main from that location to Verona Park in the near future. Councilman Ryan requests an update on the crack sealant program. The Township Manager reports that the Township has budgeted for that program, which will be done in the cooler months. The Councilman also reports to the public that the Township is in negotiations to acquire additional parking spaces at the Community Pool. He also states the rent control ordinance seems out of date and should be revised as soon as possible. He also recommends phasing in an added assessment over a 5 year period, which sparks council discussion.

Councilman Giblin acknowledges this is the first official meeting of the new Township Council and congratulates Mayor McEvoy, Deputy Mayor Roman and Councilwoman McGrath. He comments that the fireworks were great. He also reports that a resident contacted him about a tree limb blocking the stop sign at Linden and Wildwood.

Councilwoman McGrath thanks Congresswoman Mikie Sherrill for swearing Ms. McGrath in at the Reorganizational Meeting. She thanks the Township Manager for bringing her up to speed on the basics as well as complicated matters along with Jen Kiernan and Steven Neale. She expresses her gratitude to the changes made to Facebook. Although the changes are small, she feels they are important to make to allow residents to have easy avenues to get involved. She states the Junior Woman's Club's Backpacks with Purpose helps residents in need and encourages residents to be generous, if they can.
