Minutes of a Regular Meeting of the Verona Township Council on Monday, October 21, 2019 beginning at 7:00 p.m. in the Municipal Building, 600 Bloomfield Avenue, Verona, New Jersey.

Call to Order:

Municipal Clerk reads notice of Open Public Meetings law. The notice requirements of the Open Public Meetings Act have been satisfied with respect to this meeting; specifically, the time, date and location were included in the annual notice of meetings adopted by the governing body, posted in the Municipal Building, and sent to the official newspapers of the Township, the Verona Cedar Grove Times and the Star Ledger. Additionally, the agenda for this meeting was posted in the Municipal Building and sent to the two newspapers before 4:30 p.m. on the Friday preceding this meeting.

Roll Call:

Mayor Jack McEvoy, Deputy Mayor Alex Roman, Councilman Kevin Ryan; Councilman Ted Giblin and Councilwoman Christine McGrath. Township Attorney Brian Aloia and Municipal Clerk Jennifer Kiernan are also present. Matthew Laracy is present tonight in place of Township Manager Matthew Cavallo, who is out of town.

Mayor's Report:

Mayor McEvoy calls for the pledge of allegiance.

Julius Coltre approaches the lectern to update the public on County activities. He reports that the County will pave the section of Pompton and Bloomfield Avenues later this year. They are working at Verona Park today to clean storm drains. Early voting has begun. The Municipal Clerk has the flyer. The Drug Enforcement Administration's Drug Take Back Day is October 26 and Gardens Aglow will be held on October 25.

Mayor McEvoy announces this year's Environmental Commission's Poster Contest winners and reads a proclamation.

Mr. McEvoy then reads a proclamation for the Junior Woman's Club Verona Fights Hunger Week.

The Mayor announces that a special meeting of the Township Council will be held in the Ballroom of the Community Center on Monday, October 28, 2019 at 7:00 pm. He also announces that Chief Financial Officer Matthew Laracy is present tonight is Matthew Cavallo's absence.

Manager's Report:

Mr. Laracy reports that Reconstruction of Park Avenue, South Prospect Street and Harrison Street Paving is scheduled to begin on Tuesday, weather permitting. Notices are being hand delivered to affected residents. Alerts will be sent via NIXLE and through the Schools when confirmed. Town Hall will be open on the General Election Day and on Veteran's Day this year. The Verona Music Parents Association invites you to attend the third Annual NJSMA Marching Band Festival! Great Music, Food Trucks & Family Friendly. It will be held this year on Saturday, October 26 at Verona High School. The EV Charging Station at Town Hall is officially activated and fully functional. Currently the device is set up with no fee charged. We plan to introduce a Fee Ordinance in November for use of this Station. The Downtown Trick or Treating event will be on Halloween, Thursday, October 31 from 2:00 p.m. to 4:00 p.m. It is being sponsored by the Verona Chamber of Commerce, Township of Verona, Sustainable Verona and the Junior Woman's Club of Verona. The event will kick off from the Verona Civic Center, 600 Bloomfield Ave. The Junior Woman's Club will have a list of participating businesses and their discount cards for sale. The Chamber of Commerce and Sustainable Verona will have information on buying local, dining guides, handouts and ways to donate unused candy.

The Motor Vehicle Commission "Agency on Wheels" program will be here in Verona on Thursday, November 14 from 10:00 a.m. to 2:00 p.m. outside the Community Center. More information is available on the Verona website.

This year's Veteran's Day Remembrance Ceremony will be held Monday, November 11 at 11:00 a.m. at the Civic Center. The Fair in the Square will be Saturday, December 7 from 12:00 p.m. to 5:00 p.m. at the Civic Center. The Town Menorah Lighting is scheduled for Sunday, December 22 in the Civic Center.

Councilmember Reports:

Deputy Mayor Roman states that he received and read a lot of the public's comments regarding the billboards. He states that public comment is very important and encourages all to keep participating.

Councilman Ryan reports that the Verona Park Conservancy held its fall clean-up Saturday and was gratified by the turnout. He reports that the high school Environmental Club participated. WHEREAS, KM Construction Corp, 14 Cordier Street, Irvington, New Jersey 07111 was the sole responsive and responsible bidder in the Base Bid Amount of \$370,466.09 for Section 1 and the Base Bid Amount of \$199,293.22 for Section 2 for a total of \$569,759.31; and

WHEREAS, the Township Engineer has reviewed and recommends the Contract award be made to KM Construction Corp, as the lowest responsive and responsible bid.

NOW, THEREFORE BE IT RESOLVED by the Township Council of the Township of Verona, in the County of Essex, New Jersey that the contract for Contract No. 19-02A be awarded, pending approve of the County of Essex Community Development Block Grant coordinator, to the lowest responsive and responsible bidder, KM Construction Corp, 14 Cordier Street, Irvington, New Jersey 07111 in the total amount of \$569,759.31.

WHEREAS, the Township Manager/Qualified Purchasing Agent has recommended that the Reiner Pump Systems, Inc., 53 US Highway 206, Stanhope, New Jersey 07874 be awarded a contract to provide the aforementioned goods; and

WHEREAS, the award of the contract to Reiner Pump Systems, Inc. is being made pursuant to *N.J.S.A.* 19:44A-20.5.

THEREFORE, BE IT RESOLVED by the Township Council of the Township of Verona, in the County of Essex, New Jersey that Reiner Pump Systems, Inc., 53 US Highway 206, Stanhope, New Jersey 07874 is hereby awarded a contract to provide the aforementioned goods in the contract amount of \$39,900.
