

Minutes of a Regular Meeting of the Verona Township Council on Monday, May 17, 2021, beginning at 7:04 p.m. via Zoom video conferencing platform.

Call to Order:

Municipal Clerk reads notice of Open Public Meetings law. The notice requirements of the Open Public Meetings Act have been satisfied with respect to this meeting of the Township Council which is being held via Zoom video conferencing due to restrictions on indoor public gatherings resulting from the COVID-19 pandemic. Specifically, the time and date were included in the public meeting notice. This information, along with the public internet link and telephone call-in information was posted in the Municipal Building, and sent the official newspapers of the Township, the Verona-Cedar Grove Times and the Star Ledger and MyVeronaNJ.com, TAPinto and the Verona/Cedar Grove PATCH, the official online news source(s) of the Township, at least 48 hours preceding the start time of this meeting. A public comment period will be held in the order it is listed on the meeting agenda and instructions on how to comment will be provided at the appropriate time. This meeting is being recorded, both audibly and visually for retention purposes and for rebroadcast on the Township's YouTube.

Roll Call:

Mayor Jack McEvoy, Deputy Mayor Alex Roman, Councilman Kevin Ryan, Councilman Ted Giblin and Councilwoman Christine McGrath. Township Manager Matthew Cavallo, Brian Aloia, Township Attorney and Municipal Clerk Jennifer Kiernan are also present.

Mayor's Report:

Essex County Liaison Julius Coltre congratulates the mayor on his re-election and states that Councilmen Ryan and Giblin will be missed. Mr. Coltre reports that the Pfizer vaccine is now available to young adults ages 12 and up at the old Kmart in West Orange. They must be accompanied by a guardian. Walk-in locations are still open to adults wanting to receive the vaccine. There will be no food distribution this week, but next week food distribution will be held at Irvington High School. The Essex County Summer Concert Series is on, with a modified schedule. The County will hold the annual shredding program on June 19 at 99 West Bradford Avenue in Cedar Grove. Mr. Coltre reminds the public to visit [www.EssexCovid.org](http://www.EssexCovid.org) for testing locations.

Mayor McEvoy reads a proclamation for Asian American and Pacific Islander Heritage Month.

He thanks all candidates who ran in the Municipal Election and for putting up strong campaigns. He welcomes Chris Tamburro and Cynthia Holland to the council and looks forward to working with them. He thanks all who voted and putting trust in him and re-electing him.

Manager's Report:

Mr. Cavallo reports that NIXLE was discontinued by the Township and replaced by Alert Verona last Friday. ALERT VERONA has been pre-registered with all landline numbers, but we encourage our residents and businesses to register their cell phones and email addresses at [AlertVeronaNJ.org](http://AlertVeronaNJ.org) as soon as possible to avoid missing any important information. A postcard will be mailed hopefully next week to all houses in Verona asking them to go online and register. As of today 1,328 people have signed up for the service. All municipal buildings will be re-opening to the public beginning on Tuesday, June 1. At this time, face coverings will still be required. If you do not have one, don't worry, one will be provided for you during your visit.

The Governor and the State Legislative Leaders have hinted that they may no longer extend the Public Health Emergency which has existed since the middle of March 2020 after this last extension last week. Further restrictions may be lifted within the month. Anyone who is interested in receiving the Moderna vaccine, you may do so this Wednesday at the VCC. Call the Health Office at 973-857-4732 to reserve your spot. Anyone who is interested in receiving a vaccination but cannot drive to the site at Kmart is encouraged to call the Verona Department of Community Services at 973-857-4832 so we can assist them in getting to Kmart.

Mr. Cavallo reports that the New Jersey Housing Mortgage Finance Agency has approved our application for 9% Low Income Housing Tax Credits for the PIRHL Development on the former Cameco

and Poekel lots. We are now working with the developer to formulate an agenda on what steps we still need to complete, which includes Final Site Plan Approval by the Planning Board.

The last day to take advantage of early bird discount pricing for membership during the 2021 Pool Season was this past Saturday, May 15. Registrations received from now on include a \$25 administrative fee. A Free Rabies Clinic is scheduled for Wednesday, May 19, 2021 at the Verona Town Garage located at 5 Ozone Avenue. Dogs will be vaccinated between 6:00pm and 6:45pm and cats will be vaccinated from 6:45pm to 7:30pm. The rabies vaccine is recommended every two years (mandated every three years) and is necessary for animal licensure. A licensed Veterinarian will administer vaccinations. Animals should not be fed prior to the clinic. No appointment necessary and questions can be directed to the Verona Health Department at 973-857-4832. The next scheduled clinic will be in the fall of 2021.

Our new hardware for VTV has been backordered for almost a year now. Good news is it has finally been delivered. The technicians are coming in hopefully next week or the week after to get it up and running.

As we enter into the Primary Election season, this is a reminder that temporary signs (including political signs and construction signs) should not be placed in the public right of way. This is the area between the curb and the sidewalk or if the property does not have a sidewalk, the area adjacent to the roadway between the curb and any Township shade tree or utility pole. Any signs that are found to be in violation may be removed by DPW or Code Enforcement. In addition, no signs may be placed on public property including those of the Township, the County, the School District or the State.

Please join the Verona Police Department Outreach Unit in Partnership with EZ Ride for a Bicycle Rodeo! Students will learn bicycle safety and participate in drills to learn new skills. The event will be held again this upcoming Sunday, May 23, 2021 from 9:30 a.m. to 3:45 p.m. (time slots are assigned per age). The Township will hold the first annual Progress Flag Raising ceremony on Tuesday, June 1 at 6:00 p.m. with a rain date of June 3. County of Essex Memorial Day Ceremony is Tuesday, May 25 at 12 noon at Veteran's Park next to the Hall of Records. The Verona Memorial Day Parade is Monday, May 31 beginning at 10:00 a.m.

The Friends of the Library are now accepting donations of gently used books for their December Book Sale in 2021. In addition to the annual Book Sale in December 2021, they have an ongoing sale in the lobby of the Verona Library near the Circulation Desk. Be sure to stop by and check out the monthly topics. The book sales are their primary source of fundraising in addition to membership dues. Proceeds go to support the fantastic children's, adult and teen programming the Library hosts throughout the year.

The Independence Day Fireworks are Wednesday, June 30<sup>th</sup> (rain date is Thursday, July 1<sup>st</sup>) at dark. National Night Out is Tuesday, August 3<sup>rd</sup> from 6:00 p.m. to 9:00 p.m.

Deputy Mayor Roman congratulates the winners of the municipal election and looks forward to working with members of the council. He thanks Michael Nochimson and Jason Hyndman on their campaigns stating that it was a challenging campaign and everyone brought a lot of issues to the forefront. He thanks the Municipal Clerk with her efforts in running the election and all her hard work.

Councilman Ryan thanks the Municipal Clerk for the smooth running of the elections. He reports that the Township has been focused on parking for our residents, but has had merchants reach out to him concerned about availability of parking for their employees.

Councilman Giblin thanks all candidates and congratulates Cynthia Holland, Chris Tamburro and Jack McEvoy acknowledging that it a big decision to run for council. He wishes the best for the new council. He reports that at the last meeting of the Neighborhood Traffic & Safety Advisory Committee a number of residents on Claremont expressed concern with traffic and speed. Engineering Consultant John Jahr was present at that meeting and stated he would look to see what could be done. Councilman Giblin also brought his daughter to last weekend's bicycle rodeo. He thanks the Police Department and Recreation Department for a great event that was truly enjoyed by all kids. He also thanks Jen Kiernan, Municipal Clerk for a job well done in running the election, especially with a new system in place.

Councilwoman McGrath thanks the Municipal Clerk for her work. She was a challenger at the polls and states it was really an amazing effort to get the new system up and running. She thanks the poll workers and encourages people to utilize the Vote by Mail option, especially with a secure ballot drop box located right outside the Municipal Building. She congratulates Dr. Chris Tamburro, Cynthia Holland and Mayor McEvoy and reminds the public that this is the first time in 20 years that two (2) women are serving on the Township Council. She also thanks Jason Hyndman for running a great campaign and making monumental history in Verona as he was the first man of color to run for Council as well as receiving over 1,200 votes. She states that this election had a lot of concerning actions and statements which were the subject of conversation on social media and throughout town. She states there were a lot of edited videos and use of coded language, harassment and bullying over lawn signs and placement of lawn signs as well as a personal attack on Councilman Giblin's family, which she acknowledges as inappropriate. She states that she wants to apologize to Councilman Giblin and his family for having to endure that. She states this is exactly why she feels the need for a diversity work group and looks forward to the new council discussing that further.
