Minutes of a Regular Meeting of the Verona Township Council on Monday, October 4, 2021, beginning at 7:00 p.m. in the Municipal Building, 600 Bloomfield Avenue, Verona, New Jersey and via Zoom video conferencing platform.

Call to Order:

Municipal Clerk reads notice of Open Public Meetings law. The notice requirements of the Open Public Meetings Act have been satisfied with respect to this meeting of the Township Council which is being held via Zoom video conferencing and in person due to the COVID-19 pandemic. Specifically, the time and date were included in the public meeting notice. This information, along with the public internet link and telephone call-in information was posted in the Municipal Building, and sent the official newspapers of the Township, the Verona-Cedar Grove Times and the Star Ledger and MyVeronaNJ.com, TAPinto and the Verona/Cedar Grove PATCH, the official online news source(s) of the Township, at least 48 hours preceding the start time of this meeting. The agenda and public handouts for this meeting can be viewed online at www.veronanj.org/councilmeetings. A public comment period will be held in the order it is listed on the meeting agenda and instructions on how to comment will be provided at the appropriate time. This meeting is being recorded, both audibly and visually for retention purposes and for rebroadcast on the Township's YouTube.

Roll Call:

Mayor Alex Roman, Deputy Mayor Christine McGrath, Councilman Jack McEvoy, Councilwoman Cynthia Holland and Councilman Chris Tamburro. Township Attorney Brian Aloia and Municipal Clerk Jennifer Kiernan are also present. Steve Neale, Director of Administration and Economic Development is Acting Township Manager as Mr. Cavallo is out of town.

Mayor's Report:

Essex County Liaison Julius Coltre reports that testing is still available at both Kmart and Essex County College. FEMA is assisting with applications for grant funds at Kmart from 8am – 5pm, Monday through Saturday. The County will hold Electronic Recycling at 99 Bradford Avenue in Cedar Grove on October 16 from 8am-Noon. Strut Your Mutt is being held in Brookdale Park and Grover Cleveland Park on October 23 and Gardens Aglow is at 6pm on October 29. The Highlawn Pavilion in Eagle Rock Reservation is under new management. Mr. Coltre also reports that the fencing near the waterfall in Verona Park is being repaired.

Mayor Roman reports that Verona Fights Hunger week is October 17 through the 23rd. It is a worthwhile cause. He appreciates Councilwoman Holland's work on issues relating to flooding and advocating for us. The Mayor comments on congestion pricing, which is on the verge of implementation. New York City announced that there will be double tolling at both the Lincoln and Holland tunnels bringing a total charge of \$27 to travel in and out of New York City from New Jersey.

Manager's Report:

Mr. Neale asks the Municipal Clerk to give an update on the upcoming General Election.

Mr. Neale reports that unfortunately, since September 20, Verona has an additional 19 reported COVID cases. We are working with the County and their Transportation Office to make sure our vulnerable populations can get vaccinated as soon as possible. Anyone who needs a ride to a vaccination site, please call the Community Center at (973) 857-4832 or the Manager's Office and we will help you.

For the PFOA Remediation Update, Mr. Neale reports that On Thursday the Township received 5 proposals from engineering firms to design the required PFOA remediation for both the Fairview and Linn Drive Wells. We will be meeting later this week and next week to review and make our recommendations for award. Please reiterate to those you speak to that the water we are currently purchasing from PVWC is safe to drink and not exceeding the MCL for PFOA per the NJDEP guidelines.

As was already mentioned by our County Liaison, FEMA representatives are available at Kmart

in West Orange. Anyone looking to apply for FEMA Disaster Relief, you should visit DisasterAssistance.gov. There is a link on out homepage which provides a list of items you will need and who to expect when you are filing for assistance.

Both projects for repairs on Claremont Avenue and Afterglow Avenue have been substantially completed. We are reviewing the invoices now in order to close the Contract out.

The Town wide Block Party was a very successful event. Mr. Neale thanks The Dad Band, Hearth Realty, Eight Hills Caterers, the township staff, council and all the residents for making it a funfilled day for the whole family. We look forward to expanding the event next year

The purpose of Family Night is to provide Verona families a cleared schedule to enjoy quality time with each other. Family mealtime is an effective tool in fostering family unity and helping children and adolescents remain substance free. As the Council is already aware, Matt Laracy accepted appointment as a CFO in another municipality. Resumes have been received for the position and will be reviewed this month. In the interim, Jennifer Muscara has been appointed Temporary Chief Financial Officer.

With the expected retirements of Rick Neale as the Fire Official, a posting for replacement parttime Fire Official has been posted. Resumes are still being sought.

The Township is also in desperate need of another part-time senior bus driver. We have recently needed to cut back on some of our senior routes due to the bus driver's unavailability to work more than 25 hours per week. Anyone who is interested please contact the Township Manager's office.

Municipal Offices will be closed on Monday, October 11 in observance of Columbus Day.

Deputy Mayor McGrath thanks the VMAC team for the great list of coupons for Family Night. She attended the Valerie Run/Walk in Verona Park. She thanks Steve Neale for holding the Town Wide Block Party. She stopped at the Community Center when FEMA was there last week. She states that FEMA is encouraging all residents who incurred damage from Ida to apply for a Small Business loan as even if you are rejected, the application opens you up for more aid. The Deputy Mayor also stopped at the MVC Mobile Unit in Verona. She also attended the Bamboo Village opening.

Councilman McEvoy attended the Valerie Fund Run/Walk and met the founding couple and thanks them for their involvement. He states it's an honor to have this event in Verona Park. He reports that the American Foundation for Suicide Prevention Walk in October 10 in Verona Park. He also reports that Ariane Kitchen & Bar has closed. He thanks Ariane and Mike Duarte for all their volunteering efforts and giving back to the community. He wishes them good luck in their future endeavors.

Councilman Tamburro also attended the Valerie Fund Run/Walk. He thanks the Verona merchants for the service and being at these events. He wishes Bamboo Village all the best. He attended the Celebration of Pets that was held yesterday in the Civic Center. The Verona Festival of Banks is October 23. There will be sixteen bands present and he encourages all to attend.

Councilwoman Holland submitted her report in writing: Good Evening. Since our last meeting, I have the following updates - First, I'd like to acknowledge that today is my 13th wedding anniversary. So I want to thank my husband for his patience (although I clearly have learned a lot of patience from our marriage as well), but also recognize his support for my being up here for the residents of Verona while he's home reviewing the homework, doing the test review, feeding the kids, and walking the dogs. We've made it through 2 floods, one endless global pandemic, and countless other crazy adventures; so here's to lucky number 13!! Moving on from there:

Mr. Neale mentioned VEC's Walk to School Day initiative. I am co-chair of the event at Forest Avenue School, where my youngest is in second grade. It's a lot of fun. I want to thank the VPD assisting the students walking (and cycling - it's actually Walk/Bike day). Regarding the celebration of pets, Councilman Tamburro, you're welcome to adopt one of my dogs.

The Rec Advisory Committee held their monthly meeting; a variety of topics were discussed, including the disability inclusion initiative. I am grateful those that have reached out have received accommodation, but I do think more needs to be done to ensure we are inclusive of the disabled community.

October is Disability Awareness Month, which focuses this year on ensuring that people with disabilities have full access to employment and community involvement. With that in mind, the DEI subcommittee had our first meeting, which we'll hopefully discuss later this evening in New Business.

I want to thank the Township Wastewater system operator and our engineering staff, as well as Manager Cavallo for spending a lot of time with me at the Wastewater Treatment Plan, reviewing the maps, the SCADA, the facility, and - most notably - showing me where the river came over the retaining wall into the "old plant" - not the "new plant." We will also discuss stormwater in New Business, but for my part, I just want to say that it's been very gratifying to connect our Township Administration with relevant parties at the DEP, in particular the Project Navigation team, who will hopefully assist Verona. In addition, Rutgers responded to my request for researchers to include Verona (the Peckman River and its Tributaries) in their mapping of Ida damage. You may have seen their white van around. Rutgers is also going to take drone footage of the Peckman and tributaries, which is something our engineering staff was seeking. I'm very glad I can support our staff as they gather this necessary information.

As to flooding, I understand that Cedar Grove is likely addressing the Peckman in their meeting this evening as well. Perhaps we can collaborate positively with neighbors in the future on matters that concern the Peckman. Finally, I want to note the continuing consternation of anyone watching the progress of the federal infrastructure bill (or anyone that watched Saturday Night Live)... I cannot underscore enough how critical it is for funding from the federal government to support the states and local governments that must address water quality and climate resilience issues. As a Council, we issued a resolution and the Township Administration sent a letter urging federal action, but I encourage residents to act as well. Please have your voice heard. Thank you. That concludes my report.

- 1. The consumption of alcoholic beverages shall be restricted to the area as outlined in the site plan supplied with the application. No alcoholic beverages shall be possessed or consumed in any area not designated on this site plan.
- 2. No person under the age of 21 shall be served alcoholic beverages. Avenue Bistro or its designee shall be responsible for verifying the ages of those patrons who wish to consume malt alcoholic beverages, issue wristbands, and monitor the area to prevent "hand offs."
- 3. No person assumed to be under the influence of alcohol shall be served, permitted to walk, or allowed to drive from the Civic Center.
 - 4. Limit of two (2) beverages per transaction.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Verona, in the County of Essex, New Jersey approves the special conditions set forth and hereby consents to the Municipal Clerk, the State approved issuing authority of the Township, to the grant the Off Premise Catering permit for the Verona Conference of SCAs' Food Truck Festival on October 10, 2021 (rain date of 10/17/2021).
