ORDINANCE # 2022-03

FIXING THE SALARIES AND COMPENSATION OF THE PAID
OFFICERS AND EMPLOYEES OF THE TOWNSHIP FOR THE
2021 CALENDAR YEAR

BE IT ORDAINED by the Township Council of the Township of Verona, in the County of Essex, State of New Jersey as follows:

SECTION 3: The salaries herein fixed shall be paid as follows: All full time employees' semi-monthly, part time employees monthly or semi-monthly unless the method of payment is changed by resolution of the Township Council.

SECTION 4: Such salaries respectively shall be in lieu of any and all fees to which the respective incumbents of said officers might be otherwise entitled to by statute of ordinance

which fee immediately upon collection thereof shall be paid over to the Township Treasurer for the use of the Township.

SECTION 5: The salaries and compensation shall be effective as of January 1, 2021, unless specified.

SECTION 6: This ordinance shall take effect after final adoption and publication and otherwise as provided by law.
