#### Call to Order:

Municipal Clerk reads notice of Open Public Meetings law. The notice requirements of the Open Public Meetings Act have been satisfied with respect to this meeting of the Township Council which is being held in-person and via Zoom video conferencing. Specifically, the time and date were included in the public meeting notice. This information, along with the public internet link and telephone call-in information was posted in the Municipal Building, and sent the official newspapers of the Township, the Verona-Cedar Grove Times and the Star Ledger and MyVeronaNJ.com, TAPinto and the Verona/Cedar Grove PATCH, the official online news source(s) of the Township, at least 48 hours preceding the start time of this meeting. The agenda public handouts for this meeting be can viewed www.veronanj.org/councilmeetings. A public comment period will be held in the order it is listed on the meeting agenda and instructions on how to comment will be provided at the appropriate time. This meeting is being recorded, both audibly and visually for retention purposes and for rebroadcast on the Township's YouTube.

# Mayor's Report:

Mayor Roman announces that Verona Girl Scout Troops 20515, 20528 and 20915 are present tonight as we celebrate the Girl Scouts of America's 110 year anniversary. The Mayor invites the Troops to lead the pledge of allegiance. Mayor Roman then reads a proclamation proclaiming March 12, 2022 as Girl Scout Day in the Township of Verona.

Mayor Roman holds a moment of silence for the Ukraine conflict and asks everyone to please say a silent prayer for peace in Ukraine and those lost and pray for the safety of the families suffering through this tragic time. Mayor Roman reports that last Sunday the Council visited 4 local businesses: Jack's Café, for their 25th anniversary, and three (3) new businesses holding grand openings: Anderson Flowers, Pretty Moon Salon and Umai Sushi and Steakhouse. He compliments the impressive level of investment towards the buildings they hold their business in.

Essex County Liaison, Julius Coltre states that the County it still testing for Covid and administering vaccines at Kmart in West Orange and Essex County College in Newark. The hours are now Tuesday through Friday, 2pm – 7pm, Saturday from 8am – 2pm. There are summer job openings in the County's Parks Department at the Turtle Back Zoo and mini golf.

# Manager's Report:

Township Manager Joseph D'Arco reports that he met with the staff of the Montclair Health Department and confirmed that he will be receiving reports on a monthly basis going forward. Both the PBA and OPEIU contracts are continuing to be negotiated. Mr. D'Arco met with the Township Engineer and Township employees to begin work on the Peckman River erosion and clean-up. The DEP Emergency Permit was applied for and currently Mr. D'Arco has asked the Tax Assessor to determine the responsibility of the Right of Way and Mr. D'Arco and the Township Attorney will prepare a letter to send to the owner of Ferrante Press. Mr. D'Arco also met with Bright View Engineering to discuss PFAS water treatment, Claremont Avenue traffic patterns, the waste water treatment facility and the water system for Claridge II.

Mr. D'Arco invites Director of Administration & Economic Development, Steven Neale to the lectern. Mr. Neale gives a presentation on the Community Garden and invites Carol Thomas, Community Garden Manager to the lectern to update the Council on this year's plans.

# Councilmembers' Reports:

Deputy Mayor McGrath thanks the Mayor for his words on the Ukraine crisis. She applauds Verona's efforts in supporting the Gebbia and Cappello families. She wishes Daria and Dominic well and a speedy recovery. She states that tonight the governing body will be voting on a resolution to urge the legislature to swiftly pass Senate Bill 330 which is to restore energy tax receipts to municipalities. Since 2002 the NJ State Legislature, with the consent of multiple governors of both political parties have diverted funds from local municipalities that should have been provided to the Township. She states this diversion has totaled \$14 billion dollars. Verona's estimate of money that's been diverted by not giving us our full energy tax receipts has approached \$13.6 million dollars, \$1.2 million of that for last year alone. She is excited to vote on tonight's resolution in support of asking the Senate to quickly pass this legislation. She welcomes and congratulates all the new businesses in town and congratulates Jack's Café on their 25 year anniversary. She reports that the Shade Tree Commission is looking into a digitalized map of the shade trees in Verona. Family Night will be March 10th. The Green Team will be Wednesday at 7:00 pm via Zoom.

Councilman McEvoy states that he and Councilman Tamburro met with H2M, the consultants for the Master Plan. He looks forward to meeting with businesses and residents at the end of March and reminds the public the Master Plan survey is still online. He congratulates the police department on their new sign.

Councilman Tamburro attended the fundraiser for Dania and Dominic Friday at Avenue Bistro. He commends Verona Strong for their efforts. The group started during Covid to support the first responders. The Councilman also reports that he had a conversation with the Township Manager regarding his concerns with the Health Services agreement. He was satisfied after speaking with Mr. D'Arco and appreciates his expertise. He states that the Neighborhood Traffic & Safety Advisory Committee met and Mr. D'Arco attended the meeting as well. The Committee looks forward to make recommendations for grant funding. Councilman Tamburro also thanks the Police Chief for his presentation to the Committee on auto theft in Verona. Mr. Tamburro accepted an invitation from Forest Avenue School to join them for Read Across America this coming Wednesday. He mentions that tomorrow begins Women's History Month. He wishes to recognize Deputy Mayor Christine McGrath and Councilwoman Cynthia Holland for making history in serving the Township and is proud that the Girl Scouts have two shining examples in this room tonight.

Councilwoman Holland thanks the Mayor for recognizing that moment of silence for the people of Ukraine as well as recognition of the Russian people on both sides of this that strongly oppose it. She also thanks the Deputy Mayor for mentioning the energy tax receipts resolution. Although she will abstain from this evening's resolution she states it is important and she has advocated on many occasions for Verona to benefit from available funds. She attended the Verona environmental commission meeting as well as the Verona Recreation Advisory Committee meeting. She is looking forward to the spring sports as well as the Township Summer Program announcements which is the Recreation Department's Summer Camp Playground Program. She met with Mr. D'Arco and a resident who's very concerned about disability accessibility to these programs. Councilwoman Holland looks forward to Verona having more accessibility of these programs and welcoming and including the disabled population in our recreation programs more fully. Councilwoman Holland will also be attending the Forest Avenue School's Read Across America Week and will be reading to the second graders. She thanks Forest Avenue School for inviting her to read to the students and explains that more than anything, it was exciting to be invited because it means she would be allowed in the school and parents have not been allowed in the schools since the beginning of Covid, so the idea of reading to her daughter's class and all of her co-students in the classroom is particularly meaningful to her.

# URGING THE SWIFT PASSAGE OF S-330 WHICH RESTORES ENERGY TAX RECEIPTS

WHEREAS, taxes on gas and electric utilities were originally collected by the host municipalities to be used for local purposes and to compensate the public for the use of their rights of way; and

**WHEREAS**, when the State made itself the collection agent for these taxes, it promised to dedicate the proceeds to municipal property tax relief; since, just as municipalities collect property taxes for the benefit of school districts, counties, and other entities, the State is supposed to collect Energy Taxes for the benefit of municipal governments; and

**WHEREAS**, for years, though, State budget makers have diverted funding from Energy Taxes to fund State programs; and instead of being spent on local programs and services and used to offset property taxes, the money has been spent as successive Legislatures and Administrations have seen fit; and

**WHEREAS**, the diversion of dedicated energy tax receipts to the State's General Fund further jeopardizes this critical property tax relief funding in future years; and

**WHEREAS**, by reducing Consolidated Municipal Property Tax Relief Act (CMPTRA), which is also comprised of revenues that should be returned to municipalities, State Budget makers have been able to continue collecting Energy Taxes, while keeping additional revenue that should have been returned to provide property tax relief; and

**WHEREAS**, the cumulative impact of years of underfunding has left many municipalities with serious needs and burdensome property taxes; and

**WHEREAS**, local elected officials are in the best position to decide the best use of these resources, which were always intended to fund local programs and services; and

**WHEREAS**, Senator Singleton and Senate President Scutari have introduced legislation (S-330) that will restore, over a five-year period, Energy Tax Receipts to municipalities.

**NOW, THEREFORE, BE IT RESOLVED**, that the Township Council of the Township of Verona, County of Essex New Jersey urges the Legislature to swiftly pass this legislation and Governor Murphy sign the legislation prior to passage of the FY2023 State budget.
