

Minutes of a Regular Meeting of the Verona Township Council on Monday, May 9, 2022, beginning at 7:00 p.m. via Zoom video conferencing platform.

Call to Order:

Municipal Clerk reads notice of Open Public Meetings law. The notice requirements of the Open Public Meetings Act have been satisfied with respect to this meeting of the Township Council which is being held via Zoom video conferencing. Specifically, the time and date were included in the public meeting notice. This information, along with the public internet link and telephone call-in information was posted in the Municipal Building, and sent the official newspapers of the Township, the Verona-Cedar Grove Times and the Star Ledger at least 48 hours preceding the start time of this meeting. The agenda and public handouts for this meeting can be viewed online at www.veronanj.org/councilmeetings. A public comment period will be held in the order it is listed on the meeting agenda and instructions on how to comment will be provided at the appropriate time.

Mayor Alex Roman, Deputy Mayor Christine McGrath, Councilman Jack McEvoy, Councilwoman Cynthia Holland and Councilman Chris Tamburro are present. Township Manager Joe D'Arco, Township Attorney Brian Aloia and Municipal Clerk Jennifer Kiernan are also present.

Mayor's Report:

Mayor Roman invites Essex County liaison Julius Coltre to the lectern. Mr. Coltre reports that vaccinations and testing will be held at the Sears in Livingston, 112 Eisenhower Parkway on Thursdays and Fridays from 2-7pm and Saturdays from 8am – 2pm. Essex County's Electronic Waste Drop Off will be held at 99 Bradford Avenue in Cedar Grove on May 21st from 9am – noon. The County's shredding event will be held in the same location on June 4th from 9am – 2pm.

Mayor Roman went to the grand opening of the Headshop Bar on Grove Avenue. He reminds the public that the Interfaith Service will be held in the Civic Center next Saturday at 5pm. The Mayor congratulates MKA High School student and resident of Verona, Patricia Columbia Walsh for being named the 2022 Essex County Athletic Directors Association Scholastic Athlete Award. Sadly, long time Verona volunteer fire fighter Dave Shatzel passed away. Arrangements will be forthcoming. Mayor Roman announced there are six (6) proclamations on tonight's meeting. Manager's Report:

Township Manager Joe D'Arco reports that his team met with Jacobs Engineering regarding the PFAS Remediation. He states that Jacobs intends to shorten the time frame of the project. Mr. D'Arco will have a timeline soon. He also reports that the Township is in the process of preparing a bid package for the storm drain maintenance program. The Road Opening Ordinance and Utility Pole Ordinance will be posted for the public prior to the next meeting and a discussion will take place including public comment for those ordinances. Councilwoman Holland states that legislation was passed last week concerning infrastructure projects involving utilities and municipal right of ways. She is happy to provide the Township Attorney with that legislation. Mr. D'Arco and staff met in regards to the Collier's plan for remediation of the wells. Department Heads will be sending him their comments and afterwards it will be sent to the Council. Mr. D'Arco met with the County Executive and was granted permission to lower the Verona Lake pre-storms. Mr. D'Arco has distributed a list of ordinances that the governing body had discussed before his arrival in Verona. That list will be added to as other items come up and ordinances removed as they are completed.

Temporary Chief Financial Officer Jennifer Muscara explains the changes to the Budget, specifically in the Pool Utility. The final amount to be raised by taxes is, as a result, decreased by \$1,500.

Councilmember's Reports:

Deputy Mayor McGrath sends her condolences to the Shatzel family. The MIAAC met April 27 and discussed a calendar of multicultural events and ideas for Pride Month. She attended the Eid- al-Adha celebration at the Islamic mosque, which was wonderful. The Shade Tree Commission held a seminar for their commission members and DPW and discussed the recent trends in shade trees. This afternoon's meeting was cancelled and the Commission will meet in June.

Councilman McEvoy sends his condolences to the Shatzel family and the Yobs family. He thanks Michael and Elina Rosenblum for sharing their poetry and folk songs during the Ukrainian ceremony and flag raising. The Councilman attended the grand opening of the Head Shot bar.

Councilman Tamburro met with the team from the 40th legislative district, who will be very visible in the West Essex area. He congratulates David Held, George Donnelly and John Stockelberg for receiving their Eagle Scout badges last Saturday. They are all active in their school and in the community. The Neighborhood Traffic and Safety Advisory Committee will meet tomorrow. The Councilman sends his condolences to the Shatzel and Yobs families.

Councilwoman Holland addresses those Verona families who have lost loved ones, her heart goes out to them and she offers her deepest sympathies. She thanks the Mayor for having each of Council member read the beautiful Proclamations this evening. She chose to read the Proclamation recognizing our elder population, because she has personally benefited from the mentorship and advice of her elders. It is significant that we continue to remember all citizens in our fair community - including seniors. An inclusive community, as we aspire to be, engages our senior population as well as our families and other residents. She acknowledges the continued heavy rains we sustained recently. Increased precipitation is an unfortunate consequence of climate change that we must realize as reality. Councilwoman Holland praises Mr. D'Arco for taking the proactive step of coordinating with the County to lower the Verona Lake ahead of the storm. While we did not realize any flash flooding in the storm, it was a possibility and it is critical that we take proactive steps to mitigate flooding. The lowering of Verona lake should be a regular occurrence ahead of major storms. She also addresses Mr. D'Arco's efforts on the storm drains and looks forward to seeing our drains regularly cleared. Clearing those drains not only helps with localized flooding in neighborhoods, but also helps with water quality in the Peckman - reducing the silt accumulating in the river. She was a speaker on a panel for the State Bar Association on Electric Vehicles about make-ready programs for new developments. The Verona Environmental Commission has a meeting coming up later this week and encourages residents to engage in their upcoming clean ups - including on National Trails Day. The Verona Park Conservancy has their spring planting this weekend. So if you'd like to get dirty, this is a great opportunity to do so. Finally, she recognizes that Our Lady of the Lake celebrated the First Holy Communion of, with approximately 95 boys and girls this past weekend and the weekend before. This occasion is a tremendous milestone that took (at least) two years of Sunday school - including virtual Sunday school classes in the Pandemic.

WHEREAS, the Township is required to implement a Cyber Security Plan for the Township's water system in order to comply with the Asset Management Plan; and

WHEREAS, the Township received two quotes to perform this work; and

WHEREAS, Integrated Systems & Controls bid \$13,900 and L&P Integration ("L&P") bid \$12,500; and

WHEREAS, L&P will prepare a Cyber Security Plan that includes a vulnerability assessment, recommended solutions to reduce risks, create a backup plan and programs to provide assistance filing forms required to meet standards; and

WHEREAS, the water system of the Township of Verona also requires repairs to the computer tower for the Supervisory Control and Data Acquisition system (SCADA), a combination of hardware and software enabling the capture of data within, and automation of, industrial processes of the water system by connecting sensors that monitor equipment such as motors, pumps and valves to an onsite or remote server; and

WHEREAS, the Township received two quotes to perform this work; and

WHEREAS, Integrated Systems & Controls, Inc. bid \$10,900 and L&P Integration bid \$8,500; and

WHEREAS, L&P will perform a main site PLPCC replacement, including the repair of software corruption caused by Windows updates, license retrieval from ICONICS and Bristol, installation and programming including on-site testing and set up; and

WHEREAS, the Township Engineer recommends that a contract be awarded to the lowest responsive and responsive bidder, L&P, in the amount of \$8,500; and

WHEREAS, the Qualified Purchasing Agent has determined that the value of said services has exceeded \$17,500.00 but will not exceed the Township's bid threshold of \$44,000; and

WHEREAS, funds are available to award contracts for the services listed shall be charged to the budget accounts or capital ordinances listed on the availability of funds, a copy of said Certification is annexed to this Resolution as Exhibit B; and

WHEREAS, the award of the contract to Patrick Dorsey DBA L&P Integration is being made pursuant to *N.J.S.A. 19:44A-20.5* and the Business Entity Disclosure Certification and Political Contribution Disclosure Form completed by Patrick Dorsey DBA L&P Integration have been filed with the Township and are annexed to this Resolution as Exhibit C; and

WHEREAS, the Qualified Purchasing Agent has determined that the value of said services has exceeded \$17,500.00 but will not exceed the Township's bid threshold of \$44,000; and

WHEREAS, funds are available to award contracts for the services listed shall be charged to the budget accounts or capital ordinances listed on the availability of funds, a copy of said Certification is annexed to this Resolution as Exhibit B; and

WHEREAS, the Township recognizes the water slides at the Community Pool are in dire need of refurbishment; and

WHEREAS, no bids were received for Contract #2022-06; and

WHEREAS, on February 10, 2022 a Notice to Bidders for Contract 2022-06A "Water Slide Refurbishment at Community Pool - Rebid" was published in the Verona-Cedar Grove Times, the official newspaper of the Township, and a bid opening was held on February 23, 2022 and again, no bids were received; and

WHEREAS, if not refurbished, the water slides at the Community Pool would not be in service for the 2022 pool season; and

WHEREAS, the Director of Administration, Steven Neale and Supervisor of Building and Grounds, Len Waterman solicited firms from across the country being that no bids were received by firms located in New Jersey; and

WHEREAS, AquaShield Products, LLC located at 5896 Chandler Court in Westerville, OH 43082 and the Slide Experts located at 511 Nob Hill Trail in Franktown, CO 80116 were discovered and are accomplished and knowledgeable in the refurbishment of commercial water slides ; and

WHEREAS, when notified that the work needed to begin in time for the opening of the 2022 pool season AquaShield was not available to perform the work in that time frame; and

WHEREAS, the Slide Experts were able to confirm availability and complete the project in time for the opening of the 2022 pool season; and

WHEREAS, the Qualified Purchasing Agent has determined that the value of said services is \$65,000; and

WHEREAS, funds are available to award contracts for the services listed shall be charged to the budget accounts or capital ordinances listed on the availability of funds, a copy of said Certification is annexed to this Resolution as Exhibit B; and

WHEREAS, the award of the contract to the Slide Experts is being made pursuant to N.J.S.A. 19:44A-20.5 and the Business Entity Disclosure Certification and Political Contribution Disclosure Form completed by the Slide Experts have been filed with the Township and are annexed to this Resolution as Exhibit C; and

WHEREAS, the members of the Township Council have unanimously expressed their desire to have the project complete so that the members of the Community Pool will have full access to the water slides for the 2022 season.

THEREFORE, BE IT RESOLVED by the Township Council of the Township of Verona, in the County of Essex, New Jersey that the Slide Experts of 511 Nob Hill Trail in Franktown, CO 80116 is hereby awarded a contract for refurbishment of the water slides at the community pool, not to exceed \$65,000.00 and can begin work as soon as possible.

BE IT FURTHER RESOLVED that a notice of this action shall be published once in the Verona-Cedar Grove Times; and

BE IT FURTHER RESOLVED that the Township Manager and the Municipal Clerk are hereby authorized to enter into any agreement necessary for the aforementioned services a copy of which shall be available for public inspection in the Office of the Municipal Clerk.

Councilman Tamburro discusses the Memorial Day Parade and has recommended the Township include a Grand Marshall and other individuals who have served in the armed forces. Mayor Roman will name a Grand Marshall at the May 23, 2022 Council Meeting.

Deputy Mayor McGrath reports that the Health & Wellness subcommittee is waiting for the County's Health Assessment Plan. Councilman Tamburro states that the Shared Services subcommittee is looking to set up informal meetings with neighboring municipalities to discuss and identify potential Shared Service Agreements.

The Township Attorney, Brian Aloia states the next item on the agenda, a hearing requested by Ajaco Towing is adjourned until further notice.
