Call to Order:

Mayor's Report:

Mayor Roman explains the bifurcation of the original 2023 pool membership fee ordinance whereby the fees for volunteer rescue squad and fire department members was pulled and placed into a separate ordinance, both on the agenda for adoption this evening.

Mr. D'Arco reports that he is working on the employee stipend ordinance. More towns are joining to discuss flood control. The Friends of the Library becoming a 501 (c) 3 is in motion. Boswell Engineering is discussing the site location for the Claridge II pump station and will go out to bid soon. Mr. Boswell is continuing to work on the Green Acres/Fairview pump house. Linn Drive well is scheduled to go to bid. He reports on the status of the reconstruction of Everett Field. He is still working on the water rate study RFP. Chief Kiernan has prepared responses to all the recommendations in the Neighborhood Traffic & Safety Advisory Committee's pedestrian safety report that will be presented to the Council at the April 3rd meeting. Appointments for the two (2) Foresters will be on the April 3rd meeting agenda.

Mr. D'Arco reports for Steve Neale, who is not present this evening. Peckman River bank stabilization permits have been applied for. A meeting will be held on site. Council will be

notified should Congressman Payne be able to attend. The ADA playground will be going out to bid. In response to last meeting's discussion on banners and signs placed in the Civic Center, the administration has created a guideline on size and material of the signs requested to be installed.

Councilmember's Reports:

Deputy Mayor McGrath met with VRS members for a discussion about pool membership fee. VMAC's Family Night was March 9. She attended the Sustainable Verona Green Team meeting and Shade Tree Commission meeting as they are planning their 2023 Capital projects and will submit their report to the Administration in the next 2-3 weeks.

Councilman McEvoy congratulates both 8th grade boys and girls basketball teams on their great year. He also congratulates the junior's wrestling league in Verona, who placed first this year.

Councilman Tamburro congratulates the high school dramatics club for their production of Hello Dolly! March 18th the Boy Scout will hold their Pancake Breakfast at the Presbyterian Church. The Neighborhood Traffic & Safety Advisory Committee meets tomorrow to hear Chief Kiernan's feedback from their submitted report.

Councilwoman Holland congratulates VMAC on a successful Family Night. She commends the Girl Scouts on their 111 year anniversary. She attended the Environmental Commission meeting. She acknowledges the hard work and recommendations made from the Parks & Recreation Advisory Committee. She reminds the public that the Winter Moratorium Program ends March 15.

APPROVING VERONA COMMUNITY POOL RULES AND REGULATIONS FOR THE 2023 POOL SEASON

WHEREAS, the Verona Community Pool 2023 Season runs from Memorial Day Weekend and all weekends thereafter until Friday, June 23, 2023 when the pool will then be open to members full time through Labor Day, September 4, 2023 and;

WHEREAS, pool membership is available to Verona residents only who may purchase guest passes as needed;

WHEREAS, pursuant to *N.J.A.C. 8:26-1 et seq.*, all pool facilities must comply with existing sanitation and safety regulatory requirements for recreational bathing facilities to preserve public health set forth in the New Jersey State Sanitary Code regulations.

NOW THEREFORE BE IT RESOLVED that the Township Council of the Township of Verona, in the County of Essex and State of New approve the following rules for the 2023 Verona Community Pool season:

- **A.** The following rules and regulations are for the benefit of all members. They have been established to ensure safe and sanitary operation of the pool facilities. All members are to obey all rules and regulations as well as instructions of the Manager and staff employees at all times. Parents must read and explain these rules to their children. Any failure to comply with these rules shall be considered sufficient cause for immediate suspension of pool privileges of the offending person by management. The Verona Pool management shall establish additional rules as required.
 - 1. No one is allowed in any pool unless a lifeguard is on duty.

- 2. Deep water test may be required for use of any diving board or slide. Goggles cannot be worn on the slide or diving boards.
- 3. All members will be issued identification tags which must be shown at the front gate for admission to the pool.
- 4. Illegal transfer of badges, giving of false information or defacing of identification badges will result in revocation or suspension of membership. False or misleading representation on the pool membership application will result in an automatic revocation of the pool membership.
- 5. Lost membership tags must be reported to the Front Office or Office of Community Services immediately.
- 6. Membership in the Verona Community Pool is limited to Verona residents only. Members are allowed in the pool facility only during regular operating hours.
- 7. The babysitter badge, can only be used when the babysitter is with the children listed on the same membership.
- 8. Only adult memberships can purchase a guest pass.
- 9. Members and guests must comply with the rules. Members are responsible for their guests.
- 10. Day Passes are available for purchase by Verona Residents only. Purchasing Day Passes are limited to three times. They can only be purchased Monday to Friday. They are not available Memorial Day, July 4th or Labor Day. In the instances that the pool is closed due to poor weather conditions, a Rain Date Day Pass will be issued if the pool closes before 4pm. Rain Date passes can be used on another day Monday to Friday.
- 11. All coolers will be inspected before entering the pool grounds. No glass, glass containers or alcohol is permitted in the pool and will be confiscated.
- 12. Persons suspected of being under the influence of drugs or alcohol will be removed from the pool facilities.
- 13. Please remember that we have a gender neutral/family restroom that is available to use at the pool. Parents & caregivers should not bring children over the age of 6 into the rest room of their opposite gender parent or caregiver and instead use the family restroom.
- 14. Report any sign of a fecal accident to the manager immediately. Following a fecal accident in any pool, the pool will be cleared of swimmers for a minimum of one hour. The chlorine residual will be immediately checked and adjusted appropriately. This is by recommendation of the Board of Health.
- 15. Portable radios, television sets and/or music players of all types must be used with earphones.
- 16. Smoking of any kind is not allowed on the pool grounds or in the pool parking lot.
- 17. No horseplay of any kind in the pool or pool areas. No balls, toys, etc. permitted in the pool or on the deck/grass areas around the pools. Balls may be used only in the recreation area.
- 18. Any conduct that endangers the safety of others or other patrons' use of the facilities shall be prohibited. No profanity, harassment, intimidation, or bullying of patrons or staff will be tolerated.
- 19. Following items are strictly enforced in the pool perimeter;a. Walking of bicycles within the pool gates.

- b. Skate Boards will be turned into the office.
- c. Water pistols of any kind are prohibited.
- 20. Only children up to the age of 7 will be permitted in the baby pool.
- 21. All children under age 12 must be accompanied by an adult (18 years of age or over) to be admitted to the pool complex.
- 22. No diving into the pool except from the diving boards. Jump feet first only off the 5 ft. wall.
- 23. Only the Verona Pool provided Life Vests are permitted in the pool. No other floatation devices are allowed at any time.
- 24. Consumption of alcoholic beverages is strictly prohibited on pool property.
- 25. There shall be no animals, littering, glass or breakable containers allowed.
- 26. Swimmers are required to clear the water 20 minutes prior to closing.
- 27. Parents are responsible for their children. An adult must accompany children 5 and under at all times.
- 28. Diapers must be changed in the rest room area and disposed of in the container provided. Absolutely no changing of diapers on picnic tables.
- 29. According to N.J.A.C. 8:26-5.4, all children in diapers must wear plastic pants with snug fitting elastic waist and leg bands when entering pool.
- 30. All persons shall shower before entering the water.
- 31. Dressing and undressing is permitted only in the locker room; discretion must be used in the locker rooms when showering/dressing.
- 32. Board of Health Rules and Commission Rules prohibit urination on the pool grounds or in the pool water.
- 33. Destruction of or defacing of pool property will result in suspension or revocation of membership and expulsion from the pool grounds.
- 34. The pool staff are not responsible for valuables brought into the pool.
- 35. Any person having a communicable disease, open blisters, cuts, sore or inflamed eyes, ears, nose or mouth infections, excessive sunburn or any type of skin disease will be excluded from the pool area.
- 36. There shall be no running or throwing of objects.
- 37. Unnecessary spouting of water, snapping of towels, roughness, or other conduct affecting the safety and comfort of others, shall not be permitted.
- 38. No loitering in the vicinity of Lifeguard stands, entrance ladders, stairs or ramp.
- 39. Pool patrons are not permitted to put up personal tents or umbrellas on pool property.
- 40. Patrons who occupy tables must be present on the pool premises.
- 41. Tables designated for the disabled are to be only used by pool members with a person with disability present.
- 42. Tables for disabled persons are marked and are reserved for individuals with disabilities and their families or guests.

- 43. Weather Closures- The Pool facility is equipped with a THOR GUARD Lightning detection system. It will sound a long horn when lightning is close. The pool facility will be closed then. ALL members must leave the facility at that time. The closing will be sent out through CommunityPass. The Thor Guard will sound three short horns when the lightning has passed. If the poor weather passes before 4pm, the pool will reopen. That information will be sent out through CommunityPass.
- 44. The Pool Manager or Assistant Manager may close or limit the swimming pool facilities whenever, in their judgment, such action is deemed necessary or desirable for safe operation of the pool.

Baby Pool & Splash Pad is open 10am every day for children 7 years & younger when accompanied by one or both Parents/Guardians.

Access is ONLY for the Baby Pool & Splash Pad. There is no access to the main pool, slides or any activities on the main pool grounds. Access to the Baby Pool/Splash Pad is through the main gate check in.

NO CHILDREN UNDER 18 ALLOWED IN THE MAIN POOL OR MAIN POOL DECK DURING THE WEEKEND "ADULTS ONLY" HOUR. <u>POOL OPENS FULL TIME FRIDAY, JUNE 23th, 2023 AT 12 NOON</u> <u>HOURS of OPERATION for 2023 POOL SEASON</u>

WHEREAS, LEAP Implementation Grants exist to support costs associated with shared service implementation to ensure that meaningful, efficiency generating initiatives are not hindered by short term transitional expenses; and

WHEREAS, the Borough of North Caldwell, Borough of Essex Fells and the Township of Verona propose to enter into a shared services agreement, but face certain expenses associated with implementation that present a burden to the local units; and

WHEREAS, the purpose of this shared services agreement is to enhance shared services with the North Caldwell-Essex Fells Court, which will benefit the residents of all participating local units; and

WHEREAS, the Borough of North Caldwell has agreed to be the lead agency in this program and will submit the application to DLGS on behalf of all participating units.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Verona, that the Borough of North Caldwell will apply for a LEAP Implementation Grant in an amount not to exceed the maximum award amount of \$400,000.00 to support implementation of this shared service.

- 4. The Council hereby authorizes the Township Manager, or his designee, to execute any and all documents and take any and all actions necessary to complete and realize the intent ant purpose of this resolution.
- 5. The Township is in receipt of the vendor's Contribution Disclosure and Stockholder Disclosure Certification.
- 6. Contractor may be paid upon passage and certification of this resolution, and for a period of ninety (90) days thereafter, before the final execution of a contractual agreement. Said payments shall be in accordance with this resolution and the RFP as is fully delineated herein. If a finalized contract is not entered within ninety (90) days following the date of the herein resolution, all work and payments will be put on hold until the contract is finalized. The vendor shall be entitled to payment upon submission of an appropriate invoice for all work authorized and performed during the ninety (90) day period but not for any work performed thereafter until and unless the contract is finalized and fully executed by both parties.
