Pool construction is pretty much done. Mr. Neale gives a list of boards/committee/commission positions open for public members and provides information on the disbursements from the Children's Fund.

Deputy Mayor McGrath reports on Congresswoman Sherrill's efforts to include authorizing the Army Corp of Engineers to perform a watershed study of the Peckman River in the National Defense Authorization Act, signed earlier this week by President Biden. She attended the Verona Green Team meeting, the Multicultural Inclusion and Accessibility Advisory Committee meeting, the Shade Tree Commission meeting earlier this evening and will attend the VMAC meeting on January 18th.

Town Esminos

Councilman McEvoy recognizes the Verona Police Department and the danger they put themselves in each day on the job.

Councilman Tamburro thanks the police department, fire department, rescue squad and DPW for working over the holidays. He reports that the Local Emergency Planning Council met this month. The Neighborhood Traffic & Safety Advisory Committee will meet tomorrow.

Councilwoman Holland recaps her goal in running for Council in 2021 was to improve infrastructure. In 2022, the Township grappled with wells, storm water, the pool and roadwork. Year 2023 brings improvements to the wastewater treatment facility and continued infrastructure renovations. She urges the administration to continue to look for funding. She cites the utility workers working over the holidays due to a strained grid creating emergency requests for electricity.

WHEREAS, FSC has completed and submitted a Business Entity Disclosure Certification which certifies that FSC has not made any reportable contributions to a political or candidate committee in the Township of Verona in the previous one year, and that the contract will prohibit FSC from making any reportable contributions through the term of the contract.

AWARDING CONTRACT TO VCI EMERGENCY VEHICLE SPECIALISTS FOR THE PURCHASE ONE NEW 2019 TYPE I, FORD 550, MODEL 623 AMBULANCE FOR THE VERONA RESCUE SQUAD

WHEREAS, the Verona Rescue Squad ("Squad") recommends that Verona procure new Ambulance for its use by the Squad in fulfilment of their mission to the residents of the Township replacing the 2008 Ambulance owned by the Verona Rescue Squad; and

WHEREAS, the Squad has researched vendors that would achieve their goals and determined that the sought-after equipment may be procured through a nationally-recognized and accepted cooperative purchasing contract between the Houston-Galveston Area Council ("H-GAC") and Bay Head Investments, Inc. dba VCI Emergency Vehicle Specialists ("VCI"); and

WHEREAS, pursuant to *N.J.S.A.* 52:34-6.2b(3) (as amended by *P.L.* 2011, *c.*139) and LFN 2012-10, a New Jersey municipality may purchase goods and services without public bidding under the Local Public Contracts Law through the use of a nationally-recognized and accepted cooperative purchasing contract that has been developed utilizing a competitive bidding or contracting process by another contracting unit within New Jersey or another state; and

WHEREAS, H-GAC is a regional organization of governments operating under the laws of the State of Texas and is a political subdivision of the State of Texas; and

WHEREAS, the subject cooperative purchasing contract was awarded by H-GAC to VCI utilizing a competitive contracting process; and

WHEREAS, also pursuant to *N.J.S.A.* 52:34-6.2b.(3) (as amended by *P.L.* 2011, *c.*139) and LFN 2012-10, prior to making purchases under nationally-recognized and accepted cooperative purchasing contracts, the municipality must determine that the use of the cooperative purchasing contract shall result in cost savings after all factors, including charges for service, material, and delivery, have been considered; and

WHEREAS, the Squad have determined that Verona's use of the H-GAC cooperative purchasing contract to procure the sought-after ambulance will result in cost savings to Verona; and

WHEREAS, consistent with the H-GAC cooperative purchasing contract and needs of Verona, VCI has submitted a proposal to provide one (1) new 2019 Type 1, Ford F550, Model 623 ambulance to Verona for the sum of \$350,000; and

WHEREAS, the Temporary Chief Financial Officer has certified that sufficient funds are available for this purchase in Bond Ordinance No 2019-17 (Capital Account # C-53-46-031-001).

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Verona, in the County of Essex, State of New Jersey, as follows:

- 1. The foregoing "Whereas" clauses are hereby incorporated as if fully restated.
- 2. A contract for the purchase of one (1) new 2019 Type 1, Ford F550, Model 623 ambulance for the sum of \$300,000 is hereby awarded to VCI without the Township soliciting public bids as permitted by law.
- 3. The Township Manager and Township Clerk are hereby authorized and directed to execute an "End User Agreement" with VCI pursuant to the terms of its nationally-recognized and accepted cooperative purchasing agreement with the Houston-Galveston Area Council.
- 4. The form and terms of the End User Agreement shall be consistent with this resolution is subject to the approval of the Township Attorney.

There is discussion about the RFPs received for 2023 Professional Services. The Township Attorney's appointment will be on the next meeting. Mr. D'Arco advises that after that appointment, all professionals who submitted RFPs should be appointed so that they are "on standby" for the Township.

Steven Neale requests direction from the governing body regarding Cannabis dispensaries in the Township. Do they need more information from the Township Administration? Do they want the Administration to create a survey or jump into drafting an ordinance? The Deputy Mayor suggests DMR coming to a meeting to discuss the memo they created at the Council's request. The Mayor would like to discuss potential locations before coming to a conclusion. There is unanimous to table the discussion until the next meeting.

There is discussion about the zoning ordinance amendment to the plant placement and selection section. The list is located at the beginning of Chapter 150 along with the Zoning Map and Summary of Permitted Use Bulk Schedule.

Discussion on shortening the length of a Council Meeting will be on the January 9 meeting agenda per Councilman Tamburro's request.
