Minutes of a Regular Meeting of the Verona Township Council on Monday, February 27, 2023, beginning at 7:00 p.m. in the Municipal Building, 600 Bloomfield Avenue, Verona, New Jersey and via Zoom video conferencing platform.

Call to Order:

Municipal Clerk reads notice of Open Public Meetings Act.

Roll Call:

Mayor Alex Roman, Deputy Mayor Christine McGrath, Councilman Jack McEvoy, Councilwoman Cynthia Holland and Councilman Christopher Tamburro are present. Township Attorney Brian Aloia, Township Manager Joseph D'Arco and Municipal Clerk Jennifer Kiernan are also present as well as Steven Neale, Director of Administration and Economic Development.

Mayor's Report:

Mayor Roman invites Essex County Liaison, J. Coltre to the lectern. Mr. Coltre reports on this year's Essex County Deer Management Program, COVID testing and vaccination locations throughout the County and this year's Cherry Blossom Festival. There will be an Earth Day celebration at the Environmental Center on April 22nd.

Mayor Roman attended the VRS Pancake Breakfast. Special Meeting to hold Budget Workshops will be on 2/28 and 3/2. The Planning Board will continue hearing the Spectrum360 application during a special meeting on March 16 and at the regular meeting on 3/23. He requests a discussion on the review of the Zoning Ordinance process. He announces that the Council will hold a Public Comment period after Council Member's Reports.

Manager's Report:

Township Manager Joe D'Arco invites Interim CFO Jennifer Muscara to the lectern to provide the Council with an update on finances and budgeting. She shows an Open Space presentation suggesting an increase in the Open Space tax.

Mr. D'Arco reports that he will present a resolution for the March 13 meeting agenda appointing Neglia Engineering to the reconstruction of Everett Field. They will provide a design within 6 months. He reports that he recommends Fairview Insurance Agency to review our contract with BMED and requests the Council's consent. Vote: Unanimous. He will discuss the possible locations for relocating the police department in Executive Session. The Co-Chairs of the Shade Tree Commission will be invited to all future pre-construction meetings.

Steve Neale reports the pool construction and the Reconstruction of Derwent Avenue is on schedule. Boswell Engineering will design the specs for the reconstruction of Balston, Whitney and Windemere and he plans to go out to bid this summer and have construction completed before the end of 2023. The Sport Swap donation will be on 3/17 and residents can shop the swap on 3/18. The 501(c) 3 paperwork had been submitted for the Friends of Verona Parks. The bid opening for the Township Forester will be on March 1.

Councilmember's Reports:

Deputy Mayor McGrath attended the VRS Breakfast where Congressman Donald Payne, Jr. was in attendance. The Shade Tree Commission has their reorganization meeting. The Multicultural Inclusion Accessibility Advisory Committee met and further discussed planned events.

Councilman McEvoy also attended the VRS Breakfast. He congratulates Chris Bernardo, the newest member of the Planning Board.

Councilman Tamburro discusses the removal of a religious institution's sign advertising an event and his objections and suggests to discuss the matter further in Executive Session. He congratulates Jen Muscara on passing the Certified Financial Officer exam and thanks the Rescue Squad for responding to his home as he experienced a medical condition.

Township Attorney Brian Aloia advises that the removal of the sign is a discussion on policy,

which the governing body does not have in place and therefore constitutes a discussion in Open Session.

Councilwoman Holland reports that the Parks & Recreation Advisory Committee had a discussion on Everett Field and the pool fee ordinance and have suggestions on both topics. The Public Library hosted a genealogy workshop last weekend, which she attended. She will be reading to the students at Forest Avenue School for Read Across America this Thursday. She reminds the public that the NJ Winter Termination Program will end on March 15.

The Township Attorney reports that the Administration received a complaint about signs posted for activities held by Township religions institutions. Because there is no policy in place regarding the content of signage, should the Township allow one sign, without a policy, all requests to post signs would have to be allowed. He recommends the Council set a policy or deny all requests from organizations requesting to advertise and event on Township property.
