**WHEREAS**, the Township of Verona has received \$16,921.26 from the County of Essex in the form of the 2023-2024 Municipal Alliance Grant and wishes to amend its CY2023 Municipal Budget to include this amount as a revenue.

**NOW, THEREFORE, BE IT RESOLVED** that the Township Council of the Township of Verona, in the County of Essex, State of New Jersey hereby requests the Director to approve the insertion of an item of revenue in the CY2023 Municipal Budget in the sum of \$16,921.26 which is now available as revenue from:
