WHEREAS, the Township of Verona has received \$23,000 from the State of New Jersey in the form of the DCA ARP Firefighters Grant and wishes to amend its CY2023 Municipal Budget to include this amount as a revenue.

NOW, THEREFORE, BE IT RESOLVED that the Township Council of the Township of Verona, in the County of Essex, State of New Jersey hereby requests the Director to approve the insertion of an item of revenue in the CY2023 Municipal Budget in the sum of \$23,000 which is now available as revenue from:
