Minutes of a Regular Meeting of the Verona Township Council on Monday, February 5, 2024, beginning at 7:00 p.m. in the Municipal Building, 600 Bloomfield Avenue, Verona, New Jersey and via Zoom video conferencing platform.

#### Call to Order:

The Municipal Clerk reads the notice of Open Public Meetings Act.

#### Roll Call:

Mayor Christopher Tamburro, Deputy Mayor Jack McEvoy, Councilwoman Christine McGrath, Councilman Alex Roman and Councilwoman Cynthia Holland are present. Township Attorney Brian Aloia, Township Manager Joseph D'Arco, Municipal Clerk Jennifer Kiernan and Deputy Township Manager Kevin O'Sullivan are also present.

#### Mayor's Report:

Mayor Tamburro begins by thanking Legislative District 40 members, all staff and Council members for joining on Friday for a tour of Verona's Public Safety Infrastructure. He attended the Lunar New Year Celebration and thanks the school system's Mandarin teachers for their active participation as well as all of the students, faculty and the Board of Ed for hosting. The County has put out to bid upgrading the Tennis Courts at the County Park to include Pickle Ball which the Mayor was very excited about. Next Monday, there will be a Special Meeting for the Department Heads to discuss their operating budgets and capital needs. Finally, Mayor Tamburro introduces Verona resident Bill Brown to speak in honor of February's Black History Month.

#### Manager's Report:

Mr. D'Arco discusses a meeting in Everett Field with the Shade Tree Commission. There is continued progress with the agreements and discussions regarding fire prevention with Cedar Grove and there was a meeting with the Chamber of Commerce relative to parking. The traffic light project on Pompton and Claremont is moving and CDBG projects are in process, as well as the permits for the Peckman. Mr D'Arco lastly directs the next topics of discussion regarding town projects towards Deputy Township Manager Kevin O'Sullivan.

Mr. O'Sullivan reports on residential escrow fees, the Linn Drive project, the advancing Fairview Avenue well project and Green Acres. He announces that updates on water, sewer and drinking well projects are in progress, and that the storm water control Ordinance is scheduled for introduction this evening. Information from Blue Acres is expanded upon, discussions are continuing with the Office of Climate Resiliency, and increased parking meter rates are also discussed. Discussions are continuing for a number of Energy Efficiency types of projects, an application for the Community Energy Grant Program is being worked on and a grant was received regarding the Community Center playground and ADA restroom. A number of road projects are continuing to be worked through, a number of grant applications are still pending and a full list will be discussed at the next meeting.

#### Council Discussion.

Colonel Peter Lupo, Hoplite Communications, municipal 5G expert consultant for the Township discusses the opportunity for the Council to negotiate not just the public government channel, but request support of operations, be provided with certain equipment and if not, can the Township recoup subh expenses on its bill, in the contract renewal with Comcast Television

Public Comment for Cable Television Franchise Renewal:

Eric Callocchia of NewGen Strategies and Solutions presents the water rate study to the Council. It is recommended that the Council take action to raise water consumption and sewer

fees in order to sustain the water/sewer utility. Their recommendation is to raise the 2024 rates 34% and implement a fixed quarterly surcharge as well.

#### Councilmember's Reports:

Deputy Mayor McEvoy reminds the public that the County Deer Management Program is still going on through the month of February. He lastly concludes by mentioning the upcoming Restaurant Week and extends an invitation to the opening party at Jimmy's Family Kitchen for all who would like to attend.

Councilman Roman thanks the LD40 representatives for visiting Verona and discussing a variety of things about safety facilities. He is very appreciative of the service that our volunteer agencies provided.

Councilwoman McGrath states that the Multicultural Inclusion and Accessibility Advisory Committee met. Nominations for the women of impact event are due by February 11<sup>th</sup>. She attended the Lunar New Year event. She raised concerns on the Legislative visits that the Township is conducting, and is disappointed that there isn't a chance to discuss flooding issues as well.

Councilwoman Holland also compliments both the Administration and the Verona Public Schools for the Lunar New Year event. She thanks Mr. D'Arco and Mr. O'Sullivan for tackling some hard issues, and increasing transparency and communications to our residents. She also thanks Verona's various committed residents that serve on all the different Boards and Committees and concludes announcing that the Recreation Advisory Committee will be meeting next week.

#### New Business:

Council discusses the proposed pool membership fees for 2024. They also discuss revenue generating options including offering a non-resident membership. Township Manager Joe D'Arco reminds the governing body that pool registration for the 2024 season begins April 1st. In order for a fee ordinance to be in effect by 4/1, a first reading would have to be on the 2/26 meeting agenda, adopted 3/11, and effective 3/31.
