Minutes of a Regular Meeting of the Verona Township Council on Monday, March 23, 2020, beginning at 7:00 p.m. via teleconference.

#### Call to Order:

Municipal Clerk reads notice of Open Public Meetings law. The notice requirements of the Open Public Meetings Act have been satisfied with respect to this meeting; specifically, the time, date and location were included in the annual notice of meetings adopted by the governing body, posted in the Municipal Building, and sent to the official newspapers of the Township, the Verona Cedar Grove Times and the Star Ledger. Additionally, the agenda for this meeting was posted in the Municipal Building and sent to the two newspapers before 4:30 p.m. on the Friday preceding this meeting.

# Roll Call:

Mayor Jack McEvoy, Deputy Mayor Alex Roman, Councilman Kevin Ryan, Councilman Ted Giblin and Councilwoman Christine McGrath. Township Manager Matthew Cavallo, Brian Aloia, Township Attorney, Municipal Clerk Jennifer Kiernan, Director of Economic Development and Administration Steven Neale, Chief Financial Officer Matt Laracy and Police Chief Chris Kiernan are also present.

# Mayor's Report:

Mayor McEvoy calls for the pledge of allegiance.

Julius Coltre, Essex County Liaison is on the call and reports that the Essex County Executive has issued letters to Essential Employees to carry to prove they are critical employees. The County's OEM office is fully staffed. They can be reached from 7pm – 11pm at 973-324-9750. After those hours the public can call 973-621-4411. All parks and playgrounds are closed and the public is urged to stay off the exercise apparatus. All public bids are still active at this time.

Mayor McEvoy urges the public to adhere to social distancing guidelines. He states Steve Neale did a great job getting the Chamber of Commerce up and running. He thanks Chief Chris Kiernan, OEM Coordinator Joel Martin for being ahead of the COVID situation in declaring the Township's State of Emergency. He also thanks the Township Manager for all he's done. He states he has received good feedback from parents and thanks Dr. Dionisio and the Board of Education for their implementation of online learning.

Mayor McEvoy also reports that he has conferred with the Councilmembers who all were in agreement to waive tonight's Councilmember's Reports in light of tonight's conference call meeting.

# Manager's Report:

Mr. Cavallo reports that the Township has three (3) confirmed cases. There have not been any new confirmed cases of patients diagnosed with COVID-19 since Thursday. Please be advised that there are federal and state regulations that prohibit the disclosure of the identity of the patients confirmed to have COVID-19. Our public buildings have been closed to the public since 3/13/20. Township and BOE public recreational facilities are closed and fencing has been erected to close off the playgrounds at Township parks. Schools were roped off with caution tape. The rims on the basketball courts are being removed by DPW.

The Township declared a local State of Emergency as of Friday 3/13/2020. The OEM staff has been working around the clock to ensure our employees, residents and visitors are informed of the information they need to know without overloading them with information.

Beginning Monday, March 16, the Township established a rotating staffing schedule in our administrative offices and the Police Department to ensure 6 feet of distancing. DPW rotating schedules began today. All staff have increased the frequency of disinfecting all township work areas. Beginning tomorrow, March 24, municipal offices will be staffed between 9 a.m. and 1 p.m. All boards, committees and commission meetings have been postponed until further notice with the exception of the Township Council and the Board of Education.

As of today all employees have been advised that they are "essential" as it relates the EO-107 issued Saturday, however, they have been advised to work from home if feasible. Most employees have secure access to email and their network files and the township phone lines can be programmed to forward to home landlines and/or cell phones.

The Supervisors are still continuing to report to the office and hold down the fort.

In an effort to assist our residents and property owners with the payment of property tax and water/sewer payments online, effective March 16, 2020 the Township is waiving the \$1.05 transaction fee for anyone who submits e-Checks on-line through the Township's website. Please note that this charge will appear on bank account at the time of the transaction but will be applied as a credit on your next bill from the Township. The Township will not be waiving the transaction fees/surcharges for payments submitted online via Credit or Debit Cards. This policy will remain in effect until the State of Emergency related to COVID-19 is lifted.

Water payments are due today, and Mr. Cavallo is recommending to the Township Council that they waive all interest for payments not made on time within the grace period for the next 30 days. All water shutoffs for non-payment are suspended until further notice. Court Session for April 1 is cancelled at this point. Tax Appeal Submission deadline has been changed May 1, or 30 days from when Governor lifts EO #103 whatever is later.

A new website has been created that allows Verona businesses to post their contact info, offerings and the steps people can take to help them the most at this time. Help us share this and help keep our amazing local business community strong during this time.
