Minutes of a Regular Meeting of the Verona Township Council on Monday, April 27, 2020, beginning at 7:00 p.m. via teleconference.

Call to Order:

Municipal Clerk reads notice of Open Public Meetings law. The notice requirements of the Open Public Meetings Act have been satisfied with respect to this meeting; specifically, the time, date and location were included in the annual notice of meetings adopted by the governing body, posted in the Municipal Building, and sent to the official newspapers of the Township, the Verona Cedar Grove Times and the Star Ledger. Additionally, the agenda for this meeting was posted in the Municipal Building and sent to the two newspapers before 4:30 p.m. on the Friday preceding this meeting.

Roll Call:

Mayor Jack McEvoy, Deputy Mayor Alex Roman, Councilman Kevin Ryan, Councilman Ted Giblin and Councilwoman Christine McGrath. Township Manager Matthew Cavallo, Brian Aloia, Township Attorney, Municipal Clerk Jennifer Kiernan, Director of Economic Development and Administration Steven Neale, Chief Financial Officer Matt Laracy and Police Chief Chris Kiernan are also present.

Mayor's Report:

Mayor McEvoy opens the public meeting then allows a moment to pause for the nightly 7pm public clap-out for the first responders. He then calls for the pledge of allegiance.

Julius Coltre, Essex County Liaison is on the call and reports the County's OEM office is fully staffed. They can be reached from 7pm – 11pm at 973-324-9750. After those hours the public can call 973-621-4411. The testing center in Weequahic Park will continue on Monday, Wednesday and Friday. Appointments can be scheduled on the County's OEM website or by phone at 973-621-4411. The flag pole in Verona Park will be relocated. Meanwhile, flags remain at half-mast pursuant to Governor Murphy's order. Tomorrow the County will have a food bank at 10am in Branch Brook Park at the Cherry Blossom Center. All recipients must be in vehicles and cannot enter the park on foot.

Mayor McEvoy urges the public to adhere to social distancing guidelines. Although the Township numbers are up, it could be worse. He commends residents for being smart and sends his condolences to families who have lost friends and loved ones during this pandemic.

Manager's Report:

Mr. Cavallo reports that the Township has 98 confirmed cases and 11 deaths from COVID-19 as of 9am today. Emergency services is continue to operate without any major issues. All members of the police department are working. Two officers ended quarantine and have returned to work. Emergency services thanks everyone for the overwhelming support and donations. The Verona Lions Club donated \$3,000 in ShopRite gift cards and \$1,500 in restaurant gift cards to the Township. The Community Center has begun to distribute them to needy families in town. Anyone in need please reach out to the Community Services Department at 973-857-4800.

At this time the Township is uncertain if the community pool and summer playgrounds will operate. That decision is up to our Governor. Hopefully, the Governor's office will have guidance regarding summer recreation by the weekend.

To date the State of New Jersey's overall response rate to the 2020 U.S. Census is a 53.9%. Essex County is below that number, however, Verona is at 68.4% response rate. The Municipal Clerk has been working tirelessly to ensure Verona has a complete count, and will continue to do so. Meanwhile, the Township will continue with social media posting.

Hopefully Linn Drive will be paved on Wednesday. Residents have been notified to remove their cars from the street. The Township is allowing residents of Linn Drive to use the Community Center parking lot if needed.

The Blue Angel Thunderbirds will flyover NYC in honor of first responders tomorrow. Their

path will take them past the GWB around noon, then south over Newark to Staten Island and over to Long Island.

Mr. Cavallo wishes all Muslims a blessed and generous Ramadan.
