Minutes of a Regular Meeting of the Verona Township Council on Monday, July 27, 2020, beginning at 7:00 p.m. via Zoom video conferencing platform.

Call to Order:

Municipal Clerk reads notice of Open Public Meetings law. The notice requirements of the Open Public Meetings Act have been satisfied with respect to this meeting which is being held via Zoom video conferencing; specifically, the time, date and public internet link and telephone callin information, was posted in the Municipal Building, on the Township's website, and sent to the official newspapers of the Township, the Verona-Cedar Grove Times and the Star Ledger and MyVeronaNJ.com and TAPinto, the official online new source(s), at least 48 hours preceding the start time of this meeting. The agenda and public handouts for this meeting can be viewed online at www.veronanj.org/councilmeetings. A public comment period will be held in the order it is listed on the meeting agenda and instructions on how to comment will be provided at the appropriate time. This meeting is being recorded, both audibly and visually for retention purposes and for rebroadcast on the Township's YouTube channel and VTV.

Roll Call:

Mayor Jack McEvoy, Deputy Mayor Alex Roman, Councilman Kevin Ryan, Councilman Ted Giblin and Councilwoman Christine McGrath. Township Manager Matthew Cavallo, Victoria Lucido of the Aloia Law Firm, Township Attorney, Municipal Clerk Jennifer Kiernan and Bob Benecke of Benecke Economics are also present.

Mayor's Report:

Mayor McEvoy states that Julius Coltre, Essex County liaison is not present this evening. Mr. McEvoy states the flags are at half-staff is honor of Congressman John Lewis of the 5th District of the State of Georgia. Mr. McEvoy holds a moment of silence for Congressman Lewis, an activist who stood for equal rights, voting rights and humanity rights. He believed in peaceful protests. He is the first black lawmaker to lie in State at the Capitol.

Mr. McEvoy reminds residents to take garbage with you when leaving Verona Park. He reports that Hilltop Park has experienced deliberately set fires. He urges anyone with information to contact the Verona Police Department. He attended the virtual Meet the Mayors Event where Newark Mayor Ras Baraka presented Essex County Executive Joseph DiVincenzo with an award for working with Newark in replacing the lead pipes by securing \$120 million for the project.

Mayor McEvoy reads letters from residents commending the DPW Supervisor and Municipal Clerk.

Manager's Report:

Mr. Cavallo reports on the financial outlook for the Township. He states this year's celebration of National Night Out is cancelled due to COVID-19. He reports that municipal lot #2 was cleaned today. The Township has been working with local restaurants to ensure they have adequate space for outdoor dining. Reserving a section of lot #2 allows for three (3), four (4) or five (5) restaurants in the area to use the space for outdoor dining.

Mr. Cavallo reports that at the last Planning Board meeting, Lawrence Lonergan was re-elected as Chairperson, James Kirby was elected as Vice Chairperson and the Board adopted the settlement agreement with Bobcar.

Councilmember's Reports:

Deputy Mayor Roman has no report this evening.

Councilman Ryan has no report this evening.

Councilman Giblin implores residents to wear masks in Verona Park and urges the public to respect one another and social distance. He also states that many residents have reached out to him expressing their appreciation of the Township's efforts in opening the pool.

Councilwoman McGrath attended the Parks and Recreation Advisory Committee meeting where discussion took place about the pool, limited summer programs and fall sports. She thanks Community Services Director Jim Cunningham, the Recreation Department and the Committee for all their hard work. Ms. McGrath also addresses online comments that misrepresent her statements made at the last meeting. She reiterates that she is undecided on the stance of allowing recreational marijuana retail sales in Verona and says the best course of action is to wait for the referendum in November and wait to see if it passes and becomes law, then make an informed decision. She stresses that what people want is for their elected officials to look at positions analytically, which the Council does, and will continue to do in the future.
