Mayor's Report:

Mayor McEvoy reports that he attended the Historical Preservation Commission meeting this week. The committee rehashed items to go over. They were pleased with the Poekel property purchase and look forward to seeing the preservation of the shed.

Mayor McEvoy urges the public to check the Town calendar on the Township website for events. He thanks everyone that came out for the 9/11 ceremony and thanks Sue DeWitt, Lenny Waterman & the 9/11 committee along with DPW for setting up the event and helping place the flags in the Civic Center.

Manager's Report:

The rebid of the Pool Renovations Project is currently out to bid. An addenda was issued and the new bid date is September 30. Bids will be available on BidNet for the Collection, Removal and Disposal of Recyclable Materials tomorrow. The bid date on this bid is October 14. RFPs for our 2021 Professional Service Contracts, specifically attorney and engineering services, will be available tomorrow. The bid date on these RFPs is October 20.

The PIRHL Developers application to the New Jersey Housing and Mortgage Finance Agency (HMFA) was submitted last week. Mr. Cavallo thanks the Council and Planning Board for getting this done in a timely fashion.

Deputy Mayor Roman has no report tonight.

Councilman Ryan compliments County Clerk Chris Durkin, Municipal Clerk Jennifer Kiernan and the Democratic County Committee Chairperson Laura Fortgang for their timely and informative Zoom presentation on the upcoming General Election. He attended a webinar at the end of August giving landlord and tenant information on people unable to pay rent and New Jersey moratorium on evictions. He states he has ideas on how to revise the rent ordinance be wants to be careful during a period of a pandemic to not exasperate things.

Councilman Giblin attended the 9/11 ceremony. He gives a big "thank you" to Mr. Cavallo, Buildings and Grounds Department, the lifeguards and pool managers who worked to make the pool operational for 2020. He received an email from Mr. Manousos regarding traffic ideas and new developments. The Library Board has implemented a new service through an organization that offers online tutoring services to those with a library card. Councilwoman McGrath gives an update on the Recreation Advisory Committee.
