ORDINANCE No. 2019-02

**AN ORDINANCE FIXING THE SALARIES, COMPENSATION AND
RETAINERS OF THE PAID EMPLOYEES OF THE O.P.E.I.U. LOCAL 153,
AFL-CIO OF THE TOWNSHIP OF VERONA, NEW JERSEY FOR THE
PERIOD OF JANUARY 1, 2017 THROUGH DECEMBER 31, 2021**

BE IT ORDAINED by the Township Council of the Township of Verona as follows:

SECTION 1: That the salaries, compensations and retainers of the various paid employees of the Township of Verona, N. J. shall be at the following rates pursuant to the ratified Collective Bargaining Agreement between the Township and O.P.E.I.U. Local 153:

White Collar 2	\$40,932 - \$72,067
White Collar 3	\$56,861 - \$94,846
Trainee Dispatcher	\$36,330 - \$43,009
Dispatcher	\$46,780 - \$50,035
Senior Dispatcher	\$50,944 - \$75,179

SECTION 2: Salaries recorded above are base salaries.

SECTION 3: Such salaries respectively shall be in lieu of any and all fees to which the respective incumbents of said officers might be otherwise entitled to by statute of ordinance which fee immediately upon collection thereof shall be paid over to the Township Treasurer for the use of the Township.

SECTION 4: The salaries, compensation and retainers shall be effective as of January 1, 2017, unless specified, and only employees employed by the Township at the time of passage of this ordinance shall be governed by the terms of this ordinance.

SECTION 5: This ordinance shall take effect upon passage and publication as provided by law.
