**WHEREAS**, the Township of Verona has a need to acquire such services pursuant to N.J.S.A. 19-44A-20.5; and

**WHEREAS**, the Township Manager has determined that the value of said services will exceed \$17,500.00; and

**WHEREAS**, the Township Manager has recommended that JEV Construction LLC, 116 W. Main Street, 2<sup>nd</sup> Floor, Clinton, New Jersey 08809 be awarded a contract to provide said services.

**THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Verona, in the County of Essex, New Jersey that JEV Construction LLC is hereby awarded a contract for providing sewer services not to exceed \$35,000.00 without further authorization of the Governing Body.


