**AUTHORIZING A CONTRACT WITH MIRACLE CHEMICAL COMPANY**

**WHEREAS**, there exists a need for the purchase of various chemicals used in the operation of Water/Sewer Utility and the Swimming Pool Utility specifically chlorine and soda ash; and

**WHEREAS**, the Township has already purchased chemicals from Miracle Chemical Company this year totaling \$14,654.77; and

**WHEREAS**, the Supervising Operator and the Supervisor of Buildings & Grounds has recommended and the Township Manager concurs that Miracle Chemical Company shall be awarded a contract to provide said goods; and

**WHEREAS**, Temporary Chief Financial Officer has certified the availability of funds for this contract, a copy of said Certification is annexed to this Resolution as Exhibit B; and

**WHEREAS**, the award of the contract to Miracle Chemical Company is being made pursuant to *N.J.S.A. 19:44A-20.5* and the Business Entity Disclosure Certification and Political Contribution Disclosure Form completed by Miracle Chemical Company have been filed with the Township and are annexed to this Resolution as Exhibit C.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Verona, in the County of Essex, New Jersey that W.R. Neumann Company, Inc. d/b/a Miracle Chemical Company, 1151 B Highway #33, Farmingdale, New Jersey 07727 is hereby awarded a contract for the purchase of various chemicals used in the operation of Water/Sewer Utility and the Swimming Pool Utility not to exceed \$25,000.00 without further authorization of the Township Council.


