

Minutes of a Regular Meeting of the Verona Township Council on Monday, April 4, 2022, beginning at 7:00 p.m. via Zoom video conferencing platform.

Call to Order:

Municipal Clerk reads notice of Open Public Meetings law. The notice requirements of the Open Public Meetings Act have been satisfied with respect to this meeting of the Township Council which is being held via Zoom video conferencing. Specifically, the time and date were included in the public meeting notice. This information, along with the public internet link and telephone call-in information was posted in the Municipal Building, and sent the official newspapers of the Township, the Verona-Cedar Grove Times and the Star Ledger and MyVeronaNJ.com, TAPinto and the Verona/Cedar Grove PATCH, the official online news source(s) of the Township, at least 48 hours preceding the start time of this meeting. The agenda and public handouts for this meeting can be viewed online at www.veronanj.org/councilmeetings. A public comment period will be held in the order it is listed on the meeting agenda and instructions on how to comment will be provided at the appropriate time.

Roll Call:

Mayor Alex Roman, Deputy Mayor Christine McGrath, Councilman Jack McEvoy, Councilwoman Cynthia Holland and Councilman Chris Tamburro are present. Township Manager Joe D'Arco, Township Attorney Brian Aloia and Municipal Clerk Jennifer Kiernan are also present.

Mayor's Report:

Mayor Roman invites Essex County liaison Julius Coltre to the lectern. Mr. Coltre reports that the Kmart site for vaccines and testing will be open until April 16. Hazardous Waste Day will be on May 7, 2022 at 99 Bradford Avenue from 9am - Noon. Computer and Electronic Recycling Day will be held on May 21, 2022 at 99 Bradford Avenue from 9am - Noon. The Cherry Blossom Festival is happening in Branch Brook Park now. There will be a 1 mile Fun Run this Saturday at 10am. A discussion on the history of Branch Brook Park and the Cherry blossoms will be held on April 6, 13, 20 and 27 at the Cherry Blossom Center in Heller Park. All events are posted on the Essex County Parks Department's webpage.

Mayor Roman welcome the newly selected Superintendent, Diane DiGiuseppe and looks forward to meeting with her. He commends Eric Lynch who, after 20+ years leading Verona's Marching Band has announced he is leaving.

Mayor Roman attended the VBSL parade last Saturday and later that evening he attended the VFD banquet dinner.

Mayor Roman reads a proclamation for Child Abuse Prevention Month and a second proclamation for Autism Awareness Month.

Manager's Report:

Township Manager Joe D'Arco reports that the Memorial Day Parade preparation is underway. The staff is working with the newly appointed grant firm to find funding for a number of projects to be implemented in the near future.

Mr. D'Arco asks Steven Neale to give the public an update on the Peckman River. Mr. Neale reports that during the second week in March, all natural debris was cleaned out the entire length of the Peckman in Verona. The banks were secured as best they could, but Mr. Neale states that the Township is not at the bank building phase yet. The Township received authorization for a temporary solution for the bridge near Ferrante Press, where the river washed away most of the banks. Phase II will be a long term plan for bank stabilization however the DEP requires strict engineering plans for any long term solution.

Mr. D'Arco announces that Fire Chief Matt Valentine and Rescue Squad President Ricky Tempesta are present to discuss their budget with the governing body.

Councilmember's Reports:

Deputy Mayor Christine McGrath congratulates Arnold Zipf, who was honored at the VFD banquet dinner for his service on the volunteer fire department. She states it was great meeting

him and his wife. The new Multicultural Inclusion & Accessibility Advisory Committee met at the end of March. Michelle Gruet was selected as the Chairperson. The committee meets the fourth Wednesday of every Month. The April 6 meeting of Sustainable Verona has been cancelled and the Shade Tree Commission meets next Monday at 5pm.

Councilman McEvoy thanks the Verona Clergy Council for holding a service for Peace in Ukraine. He congratulates Arnold Zipf who actually had 54 years of service to the fire department. He wishes all VBSL players a great season and reminds the public to secure recyclables and if they blow over, to please pick them up because they end up in the storm sewers. He wishes everyone a Happy Ramadan.

Councilman Tamburro thanks everyone who attended the Irish Flag raising ceremony. He congratulates Arnold Zipf for his 53 years of service and hopes to honor Mr. Zipf at the next council meeting that will be held in-person. He welcome the new Superintendent. The Councilman congratulates all the cub scouts who participated in the pinewood derby this weekend. He states that as the price of fuel goes up, he hopes to look at cost saving mechanisms to reduce fuel costs for the Township.

Councilwoman Holland states April is Volunteer Appreciation Month. The Township of Verona benefits from a number of volunteers on committees, the volunteer fire department and volunteer rescue squad. The Councilwoman reports that the Parks & Recreation Advisory Committee met and discussed the Recreation Department's spring programs and pool registration. She stated there is concern that the programs are filling up quite quickly and urges the Township to get out information to parents as soon as possible prior to the registration opening up. The Environmental Commission is organizing a number of spring clean-ups and a tree sapling give away. She states that the governing body received a resolution from the Environmental Commission for consideration and hopes to add that to the agenda at a later meeting. Finally, Councilwoman Holland acknowledges the hiring of the new Superintendent and states it is a tremendous achievement for the Board of Education and having gone through the tedious process of hiring a Township Manager, she applauds them.

WHEREAS, the award of the contract to Spatial Data Logic is being made pursuant to *N.J.S.A. 19:44A-20.5* and the Business Entity Disclosure Certification and Political Contribution Disclosure Form completed by Spatial Data Logic have been filed with the Township and are annexed to this Resolution as Exhibit B; and

WHEREAS, the Russian Federation initiated an unprovoked military invasion of the democratic country of Ukraine on February 24, 2022; and

WHEREAS, Russia's invasion of Ukraine escalated into a full-scale war causing enormous civilian casualties among the Ukrainian citizens, including dozens of children, with the death toll growing by the day; and

WHEREAS, New Jersey Governor Phil Murphy sent a letter to President Biden on March 2 2022, outlining the following:

- New Jersey is home to 75,000 Ukrainian residents
- New Jersey offers support to Ukraine
- New Jersey is ready to accept refugees from Ukraine
- New Jersey requests for the Administration to consider granting protections such as humanitarian parole and Temporary Protected Status (TPS) to Ukrainians already in the US, as well as provide work permits for Ukraine DACA recipients and international student visa holders; and

WHEREAS, Township of Verona Code section [§ 370-11](#), Display of flags, allows for the display of flags on Township-owned flagpoles as the Township Council may authorize by resolution as a form of government speech; and

WHEREAS, the Township Council believes it appropriate to display the Ukrainian flag as a symbol of the Township's support of Ukraine and the Ukrainian people.

NOW, THEREFORE BE IT RESOLVED, by the Township Council of the Township of Verona, as a symbol of the Township's support of Ukraine and the Ukrainian people, the Township Manager is hereby directed to immediately schedule a flag raising of the Ukrainian flag.

BE IT FURTHER RESOLVED, that Ukrainian natives and Verona residents Michael & Elina Rosenblum are hereby invited and requested to attend the flag raising ceremony which will act as a small but hopefully meaningful symbol of the Township's support, and as prayer for peace, for the Ukrainian people.
