**ADOPTION OF THE MUNICIPAL BUDGET**

**BE IT RESOLVED** by the Township Council of the Township of Verona, in the County of Essex, New Jersey that the following statements of revenues and appropriations shall constitute the Municipal Budget of the Township of Verona for the 2022 calendar year.

**BE IT FURTHER RESOLVED** that said Budget was published in the April 4, 2022 edition of the Star Ledger, an official newspaper of the Township of Verona.

**BE IT FURTHER RESOLVED** a hearing on the Budget and Tax Resolution was held at a regular meeting of the governing body held via Zoom video conference on May 9 at 7 o'clock p.m. at which time and place discussions to said Budget and Tax Resolution for 2022 was presented by taxpayers or other interested persons.

**BE IT FURTHER RESOLVED** that copies of the budget were available in the office of the Municipal Clerk, Township of Verona, at the Municipal Building, 600 Bloomfield Avenue, Verona, New Jersey 07044 during the hours of 8:30 a.m. to 4:30 p.m. The budget was also posted on the Township's webpage at [www.veronanj.org](http://www.veronanj.org). All persons interested in the proposed budget had an opportunity to address the Township Council during the aforementioned public hearing.

**BE IT FURTHER RESOLVED** that the Township Council of the Township of Verona does hereby adopt the preceding as the Budget for the 2022 year.
