**AUTHORIZING A CONTRACT WITH PERMADUR INDUSTRIES, INC

**WHEREAS**, the Waste Water Treatment Plant requires the replacement of the 2 ton capacity free standing jib crane and hoist; and

**WHEREAS**, the scope of the work includes removal of the existing jib crane and hoist, demolition of existing concrete leveling base, installation the replacement jib crane and hoist and replacement of leveling grout; and

**WHEREAS**, the Qualified Purchasing Agent has determined that the value of said services has exceeded \$17,500.00 which is annexed this Resolution as Exhibit A; and

**WHEREAS**, funds are available to award contracts for the services listed shall be charged to the budget accounts or capital ordinances listed on the availability of funds, a copy of said Certification is annexed to this Resolution as Exhibit B; and

**WHEREAS**, the award of the contract to Permادur Industries d/b/a Sisco Material Handling, 186 Route 206 South, Hillsborough, NJ 08844 is being made pursuant to N.J.S.A. 19:44A-20.5 and the Business Entity Disclosure Certification and Political Contribution Disclosure Form completed by Permادur Industries d/b/a Sisco Material Handling have been filed with the Township and are annexed to this Resolution as Exhibit C; and

**THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Verona, in the County of Essex, New Jersey that Permادur Industries d/b/a Sisco Material Handling is hereby awarded a contract for replacing the existing 2 ton free standing jib crane and hoist for an amount not to exceed \$28,000; and

**BE IT FURTHER RESOLVED** that this contract is being awarded pursuant to N.J.S.A. 19:44A-20.5.
