RESOLUTION No. 2023-174

A motion was made by Councilwoman McGrath; seconded by Councilman Roman that the following resolution be adopted:

**AUTHORIZING A CONTRACT WITH GOOGLE
WORKSPACE BUSINESS PLUS**

WHEREAS, the Township of Verona employs the use of Google Workspace Business PLUS, including e-mail, document retention, vault and storage; and,

WHEREAS, the Township is in the second of a three-year contract with Google Workspace Business PLUS through a third party seller as Google does not contact these services out directly; and,

WHEREAS, the Township has contacted with Cumulus Global on a multi-year basis to realize discounted pricing of 30% off of Google's nationally published MSRP of \$216 per license per year and seeks to make the award as non-fair and open contract pursuant to the provisions of *N.J.S.A. 19:44A-20.; 5*; and,

WHEREAS, the Administration has determined and certified in writing that the value of the service will exceed \$17,500; and

WHEREAS, Cumulus Global, with offices at, 4 Bellows Road, Westborough, Massachusetts 01581-6129 will perform said services at a cost not-to-exceed \$19,000.00; and

WHEREAS, this expenditure shall be charged to Budget Account No. 3-01-24-264-063 or any other account that may be deemed appropriate by the Chief Financial Officer or her designee, and the availability of funds have been contingently certified by the Chief Financial Officer; and

WHEREAS, Cumulus Global has completed and submitted a Business Entity Disclosure Certification which certifies that Cumulus Global has not made any reportable contributions to a political or candidate committee in the Township of Verona in the previous one year, and the contract will prohibit Cumulus Global from making any reportable contributions through the term of the contract.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Verona that a contract is awarded to Cumulus Global with the Township in an amount not-to-exceed \$19,000.00 subject to the following:

1. The award of this contract is subject to finalization of the contract terms to be drafted and approved by the Township Attorney.
2. The contract and any contract amendments which may become necessary shall be subject to the Township's ability to appropriate sufficient funds, which appropriation shall be at the sole discretion of the Township Council.
3. The Council hereby authorizes the Township Manager, or his designee, to execute any and all documents and take any and all actions necessary to complete and realize the intent and purpose of this resolution.
4. The Township Clerk is in receipt of the Stockholder Disclosure form, Contribution Disclosure form, Certificate of Employee Information Report, Business Registration Certificate, and Certificate of Insurance.

BE IT FURTHER RESOLVED that the Township reserves the right to cancel this contract upon thirty (30) days' notice and Cumulus Global shall only be paid for the work completed; furthermore, no minimum amount of work or payment is implied or guaranteed.



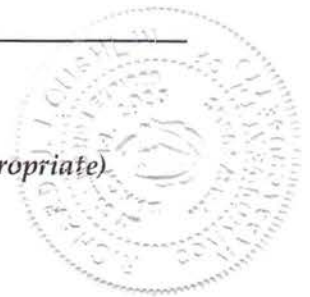
