Annual Comment on Verona Township

Issuer Profile

Verona Township is located in Essex County in northeastern New Jersey, approximately 10 miles northwest of Newark. The county has a population of 795,404 and a high population density of 6,299 people per square mile. The county's median family income is \$80,523 (1st quartile) and the March 2021 unemployment rate was 9.6% (4th quartile) $\stackrel{?}{=}$. The largest industry sectors that drive the local economy are health services, local government, and professional/scientific/technical services.

We regard the coronavirus outbreak as a social risk under our environmental, social and governance framework, given the substantial implications for public health and safety and the economy. We do not see any material immediate credit risks for Verona Township. However, the situation surrounding coronavirus is rapidly evolving and the longer term impact will depend on both the severity and duration of the crisis. If our view of the credit quality of Verona Township changes, we will update our opinion at that time.

Credit Overview

The credit position for Verona Township is very good. Its Aa2 rating is a little stronger than the median rating of Aa3 for US cities. Key credit factors include a robust financial position, a very strong wealth and income profile and a solid tax base. It also reflects an affordable debt burden and a somewhat inflated pension liability.

Finances: The township has a robust financial position, which is relatively favorable in comparison to the assigned rating of Aa2. The cash balance as a percent of operating revenues (59.7%) is notably above the US median, and saw a material increase between 2015 and 2019. Additionally, the fund balance as a percent of operating revenues (33.1%) is on par with other Moody's-rated cities nationwide. Moody's makes certain adjustments to New Jersey local governments' fund balances to include receivables and reserves that would be eligible to be included in fund balance under GAAP accounting but are excluded as a result of state statutory accounting regulations.

Economy and Tax Base: Overall, Verona Township has a healthy economy and tax base, which are favorable when compared to its Aa2 rating. The median family income is a robust 204.9% of the US level. In addition, the full value per capita (\$185,945) is above the US median, and rose materially between 2015 and 2019. Yet, the total full value (\$2.5 billion) is consistent with other Moody's-rated cities nationwide.

The coronavirus caused an unprecedented economic slowdown. We currently forecast US GDP to gradually recover in 2021. Local governments with the highest exposure to tourism, hospitality, healthcare, retail, and oil and gas could have a much slower recovery.

Debt and Pensions: Overall, the debt and pension liabilities of Verona Township are mid-ranged, yet they are unfavorable relative to the assigned rating of Aa2. The net direct debt to full value (1.5%) slightly exceeds the US median, and was flat from 2015 to 2019. Furthermore, the Moody's-adjusted net pension liability to operating revenues (1.9x) unfavorably is slightly above the US median.

Management and Governance: New Jersey municipalities have an Institutional Framework score ³ of "Aa," or strong. Revenues are moderately predictable and mostly consist of property taxes; however, cities are required to make county and school district tax levies whole in the event of tax appeals. Revenue-raising ability is moderate as cities are constrained by a 2% cap on the property tax levy. Cities can raise the levy above the cap for debt service, pensions and certain qualified expenses. Expenditures, which primarily consist of personnel and public safety, are highly predictable. Cities have a moderate ability to adjust costs given the presence of collective bargaining and high fixed costs.

Sector Trends - New Jersey Cities

Despite the ongoing pandemic, New Jersey cities as a whole will remain stable given a reliance on property taxes and highly predictable expenditures (most pandemic expenses are being paid for by the counties). Prior to the pandemic, the state economy had been expanding, albeit lagging the nation, and regions in proximity to New York City were benefitting from the spill-over effect of residential and commercial development. Growth is likely to slow as a result of the pandemic and municipalities with weak economic profiles or a high dependence on state aid are the most vulnerable to credit deterioration.


Full value of the property tax base increased from 2015 to 2019

Endnotes

- 1 The rating referenced in this report is the issuer's General Obligation (GO) rating or its highest public rating that is GO-related. A GO bond is generally backed by the full faith and credit pledge and total taxing power of the issuer. GO-related securities include general obligation limited tax, annual appropriation, lease revenue, non-ad valorem, and moral obligation debt. The referenced ratings reflect the government's underlying credit quality without regard to state guarantees, enhancement programs or bond insurance.
- The demographic data presented, including population, population density, per capita personal income and unemployment rate are derived from the most recently available US government databases. Population, population density and per capita personal income come from the American Community Survey while the unemployment rate comes from the Bureau of Labor Statistics.
 - The largest industry sectors are derived from the Bureau of Economic Analysis. Moody's allocated the per capita personal income data and unemployment data for all counties in the US census into quartiles. The quartiles are ordered from strongest-to-weakest from a credit perspective: the highest per capita personal income quartile is first quartile, and the lowest unemployment rate is first quartile.
- 3 The institutional framework score assesses a municipality's legal ability to match revenues with expenditures based on its constitutionally and legislatively conferred powers and responsibilities.
