NOTICE TO BIDDERS**

Sealed proposals for CONTRACT 19-02A: RECONSTRUCTION OF LINN DRIVE-REBID in the Township of Verona, County of Essex, New Jersey, will be received, opened and read in public on October 8, 2019, in the Council Chambers/Court Room at the Municipal Building, 600 Bloomfield Avenue, Verona, NJ at 11:00 A.M., prevailing time.

This project is for the milling and resurfacing with NJDOT approved hot mix asphalt for one (1) local street, in below fair to poor condition. The project also includes but is not limited to replacement of deteriorated granite curb, concrete curb with granite curb, concrete sidewalk and concrete driveway aprons, the installation of curb ramps where required, detectable warning surfaces at all new and existing curb ramps, NJDEP cast iron curb pieces on all inlets, bicycle safe grates where required, repair of the roadway base if needed, traffic markings, traffic striping, and incidental construction as outlined in the enclosed cost estimates.

Major Construction Items, units and quantities are:

- 9,576 S.Y. Milling Pavement – Variable Depths up to 3"
- 1,533 Tons HMA 9.5m64 Surface Course - 2" Thick
- 4,630 L.F. Granite Block Curb set in concrete

Copies of the specifications and contract documents for the proposed work may be obtained by any prospective bidder on the internet at <https://www.bidnetdirect.com/newjersey/townshipofverona>. Specifications and contract documents are on file and open to public inspection at the Township Engineers' Office, 10 Commerce Court, Verona, New Jersey on and after September 19, 2019 between the hours of 7:00 AM and 3:00 PM, Monday through Friday, excluding legal holidays. Bid documents cannot be obtained at the Engineers Office.

Each Bidder will be required to furnish a Certified Check, Cashier's Check, or Bid Bond in the amount of 10% of the Total amount of the bid. Said check need not exceed the amount of \$20,000.00 and should be made payable to the Township of Verona. In addition, each bid must be accompanied by a Consent of Surety issued by a surety company authorized to do business in the State of New Jersey to the effect that it will furnish all bonds required by the Contract documents.

Each proposal must be enclosed in a sealed envelope, bearing the name and address of the bidder and shall be addressed to the TOWNSHIP CLERK'S OFFICE, and delivered at the place and hour mentioned above. Envelope or Package must be clearly endorsed, CONTRACT # 19-02A: RECONSTRUCTION OF LINN DRIVE-REBID.

The successful bidder shall be required to execute a Contract within ten (10) days of the award of the Contract by the Township and to commence construction within seven (7) days from the issuance of the "Notice to Proceed" and complete the project within ninety (90) days from the issuance of the "Notice to Proceed."

This solicitation will be awarded via a Fair and Open Process in accordance with N.J.S.A. 19:44A-20.5 et seq. Bidder must be registered with the State of New Jersey at time of the award of the contract. Bidders will be required to present a copy of their Business Registration Certificate (BRC). Bidders must provide an Ownership Disclosure Affidavit with bid proposal, failure to provide the same is a non-waivable defect. Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27.
