TOWNSHIP OF VERONA LEGAL NOTICE BID NOTICE The Township of Verona, New Jersey shall receive sealed proposals at the Municipal Building, 600 Bloomfield Avenue, Verona, New Jersey, until 11:00 A.M., prevailing time, Friday, June 27, 2025 at which time and place sealed bids will be opened publicly and read for the following CONTRACT #2025-04 IMPROVEMENTS TO EVERETT FIELD. Copies of the specifications and contract documents for the proposed work may be obtained by any prospective bidder on the internet at <https://www.bidnetdirect.com/new-jersey/townshipofverona> on and after May 30, 2025. Bid documents cannot be obtained at the Township Manager's or the Municipal Clerk's Office. Each proposal must be made upon the prescribed forms furnished with the contract specifications. Proposals must be accompanied by a Bid Deposit in the form of a Bid Bond, Certified Check, Money Order or Cashier's Check for \$20,000.00. Each proposal must be enclosed in a sealed envelope, bearing the name and address of the bidder and shall be addressed to the MUNICIPAL CLERK'S OFFICE, and delivered at the place and hour mentioned above. Envelope or Package must be clearly endorsed, CONTRACT #2025-04 IMPROVEMENTS TO EVERETT FIELD. The Standard Proposal Form and the non-collusion affidavit are attached to the Specifications, copies of which will be furnished on application to the Engineer. Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27, regarding Affirmative Action and Executive Order 11246 regarding Equal Opportunity, and with all provisions of the Local Public Contracts Law, NJSA 40A:11-1 et. seq. and all rules and regulations promulgated thereunder, the provisions of which are incorporated herein by reference. New Jersey Business Registration Requirements: N.J.S.A. 40A:11-23.2 requires all contractors and subcontractors with public contracting agencies to provide proof of registration with the Department of Treasury, Division of Revenue. The contractor shall provide written notice to its subcontractors of the responsibility to submit proof of business registration to the contractor. The requirement of proof of business registration extends down through all levels (tiers) of the project. Before final payment on the contract is made by the contracting agency, the contractor shall submit an accurate list and the proof of business registration of each subcontractor or supplier used in the fulfillment of the contract or shall attest that no subcontractors were used. For the term of the contract, the contractor and each of its affiliates and a subcontractor and each of its affiliates [N.J.S.A. 52:32-44(g) (3)] shall collect and remit to the Director, New Jersey Division of Taxation, the use tax due pursuant to the Sales and Use Tax Act on all sales of tangible personal property delivered into this State, regardless of whether the tangible personal property is intended for a contract with a contracting agency. The Contractor is required to comply with all rules and regulations and orders promulgated by the State Treasurer pursuant to NJSA 10:5-31 et. seq. and NJAC 17:27, P.L.1975, c 127., regarding Affirmative Action, Executive Order 11246 regarding Equal Employment Opportunity, and Chapter 33, Laws of 1977 regarding disclosure of Partners & Stockholders, and all rules and regulations promulgated thereunder, the provisions of which are incorporated herein by reference, and with all provisions of the Local Public Contracts Law, NJSA 40A:11-1 et. seq. and all rules and regulations promulgated thereunder, the provisions of which are incorporated herein by reference. All bidders must be registered with the New Jersey Department of Labor. All bids shall be irrevocable, not subject to withdrawal and shall stand available for a period of sixty (60) days. The Township of Verona reserves the right to reject any or all bids, or to waive any informalities in the bidding. Small, Minority and

Women's Business Enterprises are encouraged to obtain specifications and compete for the contract. The contract governing this work is partially funded by monies received by Essex County under Title I of Housing and Urban-Rural Recovery Act of 1983 (P.L. 98-181). Under the said Act, the Davis- Bacon Act is applicable to the contracted work. Accordingly, the Contractor must abide by the provisions of the Federal Labor Standards. Which are included as a part of the conditions of the contract. All bidders must submit their Federal UEI number (Unique Equity ID) and their SAM Cage Code number (System for Awards Management- Commercial and Government Entity). Prospective Bidders without a UEI and SAM number will not be able to be considered responsible bidders, this eliminating them from any awards. The Applicable UEI and SAM numbers shall be provided with completed bid package and on the form for Contract Clearance Requirements. It is noted that sub-contractors will not need to be registered with SAM. This project is being partially funded by the New Jersey Department of Environmental Protection Green Acres Jakes Law Playground Grant.
