### **Street Tree Inventory –**

- RichView Consulting has completed the inventory on all of the town trees
  - $\circ$  100% of the data has been extracted from the GPS units
  - Consultant is reviewing and organizing data

### **Community Forestry Management Plan** –

- John Linson (Urban Forestry Consultant)
  - He has been awarded the contract to develop the new Community Forestry Management Plan for Verona.

- He received a letter from NJ State DEP the state is extending all town Community Forestry Management Plans to accommodate the new State Plan Guidelines that are expected to be released in October 2020.
- Verona's Management Plan has been extended to 12/31/23
- The Shade Tree Commission voted unanimously to proceed with creating a new Management Plan (MP) and not wait until 2023 due to:
  - The importance of this plan
  - This current management plan was created back in 2013, almost 7 years ago.
  - A lot has happened and changed since the last MP was issued we need to develop new strategies and plans on how to proceed in the next 4-5 years, and a plan on how to implement them
  - Kevin Ryan spoke to the Town Manager about this decision, and he is in agreement
