### 5. Old business

- **a.** VHPC meeting in March will be scheduled for March 10, 2022
- **b.** Preservation conferences
  - Workshops
    - Mr. Hallock participated in a training course on historic preservation which was a good overview of the whole story including history, philosophy, etc.,
      - a. "Introduction to Historic Preservation." It was offered by MARCH, the Mid-Atlantic Regional Center for the Humanities, part of the Historic Preservation Continuing Education Program at Rutgers-Camden. (online because of Covid)
  - Noted that a CLG requirement to attend and the fee would be covered.
  - Perhaps we might get an agenda.
- **c.** VHPC mailbox at Civic Center Mr. McEvoy confirmed that there was no mail.

# 6. Ongoing business

- Designations continuing ongoing status
  - Freight Shed

- a. Plans contingent on the township's purchase of the Cameco and Poekel properties for affordable housing.
- b. Ms. Smith stated that funding is still available.
- Methodist Church Plaque placement possibility.
- White Rock
  - a. Pending the need for County permission for historic designation of a county property. Perhaps in September.
- Letter to homeowners of potential landmarks
  - Steve Neale is making brochures regarding the VHPC and the historic properties in Verona as part of the educational outreach process.

#### 7. New Business

- a. New VHPC Member
  - With the departure of Nick Savva, we will need a new Class "C" commissioner.
  - The town council will need to vote on the new member.
- **b.** Fair in the Square
  - The VHPC will have a table at Fair in the Square on Saturday, December 4.
- **c.** Historic Districts
  - This was discussed at the Stakeholders meeting
    - Mr. McEvoy said that you must give notice to everyone in the district.
    - Mr. Hallock will review the Verona ordinance. On a national level you need 51% to not object noting that the Verona ordinance is deferential to property owners.
    - Other commissions are part of the review including the Shade Tree and Environmental Commissions,
  - Master plan: Discussion ensued on the current review of the master plan.
    - Mr. Hallock pointed out that view of experts is to present to local officials a way to have some control over random development in your town.
    - The ordinance as currently written has no compelling reason for a homeowner to buy into a designation. There are other towns with a differing point of view on their ordinances.
    - The proposed Master Plan is online for review.
