  - Freight Shed

  - Methodist Church Plaque placement possibility.
  - White Rock
    - a. Pending the need for County permission for historic designation of a county property. Perhaps in September.

- **b.** Mr. Houthuysen noted that the CLG report is in process and almost completed at this time.
- **c.** Historic Districts
  - This was discussed at the Stakeholders meeting and is a continued review.
    - Other commissions are part of the review including the Shade Tree and Environmental Commissions,
  - Possible districts
    - Cook Lane Historic District
    - Houses not in the Barton Ross survey which focused on houses 100 years old.
    - Mr. Hallock suggested a review of properties that are 50+ years which would include neighborhoods like Woodland Ave.
      Discussion was that this could be expanded to Grove Ave. and Everett Field.
